TITLE:	Motion Approving Increase in Funds to Contract for Uniforms – Global Trading Inc \$120,000 - (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve an increase in funds to Contract No. 473-11835 for the purchase of uniforms until the expiration of current contract on January 17, 2021, in the amount of \$120,000.

Background

On January 18, 2017, CAM #17-0034 was approved and contract #473-11835 was awarded to Global Trading, Inc., for the estimated three-year amount of \$328,029 as the supplier of uniforms required for the employees of Public Works.

In 2017, the contract was reviewed for organization-wide use to support the purchase of uniforms, as required in the Teamster and Federation contracts, to include employees of the following departments: Transportation and Mobility, Community Redevelopment Agency, and Parks and Recreation in addition to Public Works. The expansion to organization-wide use increased the annual spending from the estimated \$109,343 for Public Works to an estimated \$162,000 for all City departments.

In Fiscal Year 2019, City departments incurred a significant increase in uniform purchases due to City growth and turnover, increased participation in special events, and an increase in uniforms deteriorated and contaminated due to multiple major sewer force main failures. The current contract expires in January 2021. An increase to the allowable contract spending of \$120,000 is requested to continue to provide required uniforms for employees. This amount is an estimation based upon review of the previous fiscal year's uniform expenditures from FY19 across all City departments. All rates currently paid to the vendor will follow their awarded bid pricing and those rates will continue throughout the term of the contract.

Resource Impact

There will be a current fiscal impact to the City in the estimated amount of \$67,400. Future expenditures are contingent upon approval and appropriation of the City's operating

budgets and pending approval of the consolidated budget amendment CAM 20-0092.
