- TITLE: Motion Approving Contract for Proprietary Purchase and Utilization of Department of Justice Trust Fund for Gunshot Detection, Location and Forensic Analysis Service – ShotSpotter, Inc. - \$595,000 - (Commission Districts 2 and 3)

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, for the proprietary purchase of gunshot detection, location and forensic analysis service from ShotSpotter, Inc. in the estimated amount of \$595,000.

Background

ShotSpotter is a detection and investigative tool that provides real-time gunfire intelligence to assist the Department in its efforts to more effectively respond and investigate gunfire incidents. In addition, this tool will be part of a comprehensive plan to reduce gun violence in our community. ShotSpotter technology has a multi-faceted approach to reducing gun violence in communities. ShotSpotter detects and locates gunfire through detection devices which provide a quick, precise response to over 90 percent of shooting incidents in a targeted area. This results in a deterrent effect and disrupts the gun violence cycle. Further, ShotSpotter helps protect officers by providing comprehensive tracking data of incidents in the community as well as critical intelligence in near real-time when responding to specific incidents.

ShotSpotter also provides police departments the unique opportunity to rapidly respond to gun violence in the community that is often unreported. This often involves communities most impacted by gun violence, and law enforcement's response results in building more positive attitudes towards law enforcement and constructive engagement.

ShotSpotter also increases the amount of gunfire intelligence a law enforcement agency receives while at the same time decreasing response time and improving accuracy of the gunfire intelligence.

ShotSpotter's technology provides critical advantages in the police department's efforts to reduce and prevent gun violence in the following ways:

- Officers can more quickly and accurately respond to reports of shootings.
- Officers have a better chance of arriving before the shooter has left the scene.
- Officers are more likely to recover critical evidence such as shell casings and/or contact witnesses/victims.
- Community engagement is potentially heightened which translates into more active intelligence and aids in investigations.
- Targeted enforcement is enhanced through the accuracy of the technology.
- Additional court admissible and forensically sound evidence is available to strengthen prosecutions of the worst offenders.

Pursuant to Section 2-181(f)(3), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase proprietary items, as defined in Section 2-173, without competitive solicitation. As defined by the Code, a proprietary item is not readily available from more than one supplier, manufacturer, or person and is unique in nature, without competitive solicitation.

On June 18, 2020, the Procurement Services Division released a Notice of Intent to Award a Proprietary Purchase No. 12418-507 and received one response from Eagl Technology. EAGL's product does not meet certain specifications including audio recording of the gunfire and staffing an Incident Review Center that assists with detecting and verifying gunfire. Therefore, it was determined the product proposed does not meet the required criteria.

Resource Impact

There will be a fiscal impact to the City in the amount of \$595,000. The initial annual fee in the amount of \$205,000 will be funded from the Department of Justice Trust Fund. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 20-0092 and Commission approval of a 2021 Budget Decision Package for the remaining two years.
