TITLE: Resolution Approving an Interlocal Agreement between Broward County
and the City of Fort Lauderdale Related to COVID-19 Emergency Order
Enforcement - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

It is recommended the City Commission adopt a resolution authorizing the City Manager to execute an Interlocal Agreement with Broward County related to COVID-19 Emergency Order Enforcement.

Background

As a result of COVID-19 and the ongoing need to enforce of emergency orders, Broward County (County) has requested the City of Fort Lauderdale to enter into an interlocal agreement (agreement) that would require the City's Community Compliance and Enhancement code officers to have access to the County's QAlert system and follow up on complaints entered into the system within a specified time period, along with minimum requirements for enforcement actions taken by the City to address businesses operating in conflict with existing emergency declarations.

The agreement stipulates that under Section 8-56 of the Broward County Code of Ordinances the City has the authority to enforce the emergency declarations within the municipal boundaries of the City and the County will reimburse the City for these enforcement functions with a monthly payment to the City in the amount of \$44,000, totaling an amount not to exceed \$308,000.

Resource Impact

If this agreement is approved, in Fiscal Year 2020 the City is anticipated to receive \$44,000 per month in unbudgeted revenue for the months of June – September of 2020 for a total of \$176,000. In Fiscal Year 2021, the City is anticipated to receive an additional \$132,000 for services provided from October through December of 2020.
