

AMENDED AND RESTATED AGREEMENT

THIS IS AN AMENDED AND RESTATED AGREEMENT, made and entered into this 26 day of December, 2008 by and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of Florida, hereinafter referred to as "City,"

and

BOYS & GIRLS CLUBS OF BROWARD COUNTY, INC.,
a non-profit corporation of the State of Florida,
hereinafter referred to as "Contractor";

WHEREAS, on December 7, 1999, by Motion, the City Commission of the City of Fort Lauderdale, Florida, authorized the proper City officials to enter into an Agreement between the City and the Contractor (formerly known as "Boys Clubs of Broward County, Inc." d/b/a "The Boys and Girls Club of Broward County") to maintain benches with advertising and trash receptacles with sponsorship plaques at no cost to the City (hereinafter referred to as "Original Agreement"); and

WHEREAS, on December 21, 2004, by Motion, the City Commission of the City of Fort Lauderdale, Florida, authorized the proper City officials to amend the Original Agreement to provide for an extension of the Original Agreement for an additional five-year (5) term and to provide for adjustments to the fees to be paid to the City; and

WHEREAS, the Contractor has requested the City revise and amend several provisions related to bench and trash receptacle construction, design, installation and replacement as well as repair and maintenance of bus shelters, and to provide for an extension of the Original Agreement as amended; and

WHEREAS, on November 4, 2008, by Motion, the City Commission of the City of Fort Lauderdale, Florida, authorized the proper City officials to amend and re-state the Original Agreement as amended, to provide for an extension of the amended Original Agreement, authorized on December 21, 2004, for an additional five-year (5) term (hereinafter referred to as "Amended and Restated Agreement"), all hereafter provided.

NOW THEREFORE, in consideration of the mutual promises, covenants and agreements, and all other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree to as follows:

1. PURPOSE AND USE

The Contractor shall have the non-exclusive right to furnish and maintain benches with limited advertising, for the use of the public, at locations approved by the City Manager. Additionally, the Contractor shall have the non-exclusive right to furnish and maintain public non-advertising trash receptacles, at locations approved by the City Manager. All costs associated therewith shall be borne solely by the Contractor and the City shall have no liability for any such costs.

The proposed locations shall be public bus stops, shopping centers, business zones, regional activity centers, school bus stops and in other similar areas where they are needed for the accommodation and convenience of the public. All locations and bench installations must conform to federal, state and municipal law, ordinances, and rules and regulations.

2. INSTALLATION

(a) Permission must be obtained from the City Manager prior to the installation of benches or trash receptacles proposed to be located on public property, and the Contractor shall obtain all necessary permits at its sole cost and expense. Bench and trash receptacle installation must adhere to all federal, state and local laws, ordinances and regulations.

(b) The Contractor shall provide a written consent from a property owner approving the installation of a bench on the owner's property. Such written consent shall be submitted with the Contractor's application for permission from the City Manager to install the bench. Trash receptacles may be located on private property, subject to the prior approval of the City Manager.

(c) The parties acknowledge that, at the full execution of this Amended and Restated Agreement, there are four hundred sixteen (416) approved bench locations. Contractor shall apply for locations of additional benches in conjunction with the Contractor's quarterly reports. The City shall not unreasonably withhold its approval and shall act on the Contractor's request within fifteen (15) working days of receipt of the application.

(d) Contractor and City Manager, by mutual agreement, shall identify one hundred (100) benches existing at the full execution of this Amended and Restated Agreement for replacement by Contractor. Contractor shall replace the identified one hundred (100) benches with new fixed metal benches by December 31, 2009. An existing bench shall not be removed until a new

replacement bench has been fully installed. Benches shall be "Webb-Coated™", installed on concrete pads and conform to all necessary City permit requirements. Installation of replacement benches shall also comply with all requirements set forth in this Amended and Restated Agreement.

(e) Contractor and City Manager, by mutual agreement, shall identify an additional three hundred sixteen (316) benches existing at the full execution of this Amended and Restated Agreement for replacement by Contractor. Contractor shall replace the identified three hundred sixteen (316) benches with three hundred sixteen (316) new non-static benches by December 31, 2011 at a minimum rate of 10 benches per month. An existing bench shall not be removed until a new replacement bench has been fully installed. Installation of replacement benches shall also comply with all requirements set forth in this Amended and Restated Agreement.

(f) Contractor shall install fifty (50) new non-advertising metal trash receptacles by December 31, 2009. New receptacles shall be installed either as replacements for receptacles existing at the time of full execution of this Amended and Restated Agreement or at new locations, at the discretion of the City Manager. Selection of trash receptacle design shall be by mutual agreement of Contractor and City Manager and receptacles shall be anchored to the pavement. Locations of trash receptacles and installation of additional trash receptacles shall be by mutual agreement of Contractor and City Manager. Installation of trash receptacles shall comply with all requirements of this Amended and Restated Agreement. Contractor shall at all times maintain a current list of all trash receptacles including those receptacles in existence at the time of this Amended and Restated Agreement which shall be available for review by appropriate City personnel.

(g) The City Manager and Contractor may mutually agree upon additional or substitute bench and receptacle locations as the need may arise.

3. CONSTRUCTION AND DESIGN

(a) All benches shall be constructed of top grade materials and shall be of a uniform color approved by the City Manager. Each bench provided under this Amended and Restated Agreement shall have a single seat divider to inhibit horizontal reclining. Each bench shall be identified with a number, the name of the Contractor and a local telephone number.

The parties acknowledge that certain sections of the City have unique charm and character and Contractor may propose the installation and use of a different bench design with advertising panel, type and construction more compatible to those areas. All requests by the Contractor for approval to deviate from the standard bench construction and design shall be made to the City Manager who may approve or reject such deviation in whole or in part at his sole

discretion, provided, however, that the City Manager may refer any request to the City Commission for its formal approval.

(b) All receptacles shall be of uniform style, color and construction so as to coordinate with replacement benches as referred to in this Amended and Restated Agreement, unless otherwise approved by the City Manager. Those placed East of the Intracoastal shall be hot dipped galvanized. The Contractor shall at his sole cost and expense provide, install and maintain all such receptacles in good and serviceable condition during the entire term of this Agreement. In the event a receptacle is removed, the style and construction of any replacement receptacles shall be the same as the receptacle replaced, unless prior City Manager approval is received. Each receptacle shall have an identification number and, if installed at a location not involving a bench, the name of the Contractor and local telephone number shall also be identified.

4. BENCH, RECEPTACLE AND BUS SHELTER MAINTENANCE

(a) The Contractor shall, at his sole cost and expense, maintain all benches and receptacles in good and serviceable condition during the entire term of this Amended and Restated Agreement. The Contractor shall routinely monitor and inspect each bench and receptacle location at least two times each week, and to remove any trash found on or around the surrounding grounds area of the bench and receptacle, and to repair, recondition or replace each bench or receptacle found to be damaged or in disrepair. The Contractor shall maintain logbooks and records of the inspections it provides, and these records shall be available for the review of appropriate City personnel.

(b) As of the date of full execution of this Amended and Restated Agreement, there are twenty-two (22) Bus Shelters, as the term is defined hereunder, under the ownership and control of the City. The complete location list of these shelters appear as Exhibit A, attached hereto. The Contractor shall perform repairs on fourteen (14) transit Bus Shelters (hereinafter "Bus Shelters") owned and operated by the City to be selected from those listed in Exhibit A. Bus Shelters to be repaired will be identified by the City Manager. Contractor shall repair said Bus Shelters by performing services including but not limited to: replacing broken panes, fixing roof panels, painting, replacing mesh panels and generally repairing broken parts. Repairs shall be completed by June 1, 2009 to the satisfaction of the City Manager. The City Manager will have right of final approval for all repairs completed by Contractor. Additionally, Contractor shall begin to maintain the remaining eight (8) Bus Shelters at its sole cost and expense.

(c) Contractor shall have the ongoing duty of performing routine maintenance of all twenty-two (22) Bus Shelters that exist in the City at the time of full execution of this Amended and Restated Agreement for the term of this Amended and Restated Agreement. Maintenance shall be performed as

expeditiously as possible and include, but is not limited to: removal of graffiti, keeping the area debris-free and monthly pressure cleaning.

(d) Nothing in this Amended and Restated Agreement shall be construed as permitting Contractor to advertise or sell advertising space on, in or around Bus Shelters.

(e) The Contractor shall have during working hours sufficient personnel to answer the phone for citizens who wish to call concerning benches and receptacles. A log of complaints about benches and receptacles, including the subject of the complaint and the action taken, shall be kept and made available upon City request.

(f) The City reserves the right periodically to inspect such benches and receptacles to determine their condition. The Contractor shall replace or recondition, to the satisfaction of the City Manager, any benches or receptacles which the City Manager determines are no longer in good or serviceable condition. The style and construction of any replacement bench or receptacle shall be the same as the bench or receptacle replaced, unless prior City Manager approval is received as provided in Paragraph 3(a) and (b).

(g) In the event the City Manager shall determine that a bench or receptacle should be repaired, replaced or removed for noncompliance with this Amended and Restated Agreement, he shall give the Contractor written notice, and the Contractor shall repair, replace or remove the bench or receptacle within ten (10) working days of receipt of such notice.

(h) In the event the City Manager determines that a bench or receptacle constitutes a hazard to persons or property or seriously disrupts the public right of way, the Contractor shall remove the bench or receptacle no later than two (2) working days from receipt of such notice. In the event the Contractor fails to repair, replace or remove the bench or receptacle within the above specified periods, the City shall have the right to repair, replace or remove the said bench or receptacle at the expense of the Contractor.

5. TRASH PICKUP

It will be the responsibility of the City to provide or cause to be provided trash pickup from the receptacles at no cost to the Contractor during the Amended and Restated Agreement term including any extension terms. The frequency of such trash pickup will be determined solely by the City.

6. BENCH ADVERTISING

(a) The Contractor is authorized to sell advertising to be placed upon the benches only in the manner provided herein. Advertising of liquor, tobacco,

political matter, massage parlors, adult bookstores, adult theaters, adult escort services, pornographic, obscene or objectionable matters are prohibited. The determination of objectionable matter shall be at the sole discretion of the City Manager whose decisions shall be final.

(b) Day-glow paints or any psychedelic painting is expressly prohibited. The advertising panel shall be a maximum length of 72 inches and height of 24 inches consistent with Florida Department of Transportation Guidelines as set forth in Chapter 14-20.0032(7) (2008) titled "Placement of Benches" and be constructed of masonite or plywood or other suitable materials approved by the City. All advertising including any illustrations, designs, arrows, characters, numbers, letters and similar markings shall only be placed on the back of the bench and not on any other part of the bench. No more than fifty percent (50%) of the area reserved for advertising shall have letters or numbers larger than twelve (12) inches. An artificially lighted advertising panel is expressly prohibited. All requests by the Contractor for approval to deviate from the standard advertising panel design and construction shall be made to the City Manager who may approve or reject such deviation in whole or in part at his sole discretion, provided, however, that the City Manager may refer any request to the City Commission for its formal approval.

The Contractor shall provide up to ten percent of its advertising panels or fifty seven (57) panels, whichever the greater, for its public service advertising of the City of Fort Lauderdale or its duly authorized representatives. The Contractor shall provide the bench and the advertising panel at no additional cost to the City. The advertisement copy shall be provided by the City to the Contractor with no more than one panel change per location per year. The location of the public service benches shall be by mutual agreement between the Contractor and the City Manager.

7. RECEPTACLE ADVERTISING PROHIBITED

As Contractor has found trash receptacle advertising to be without financial gain, Contractor agrees not to sell or place advertising or sponsorship plaques upon the trash receptacles for the term of this Amended and Restated Agreement or for any subsequent extension. Contractor agrees that this prohibition shall not negate the obligation to continue paying the Annual Agreement Payment for Trash Receptacles as set out in Paragraph 9(b) below.

8. ORIGINAL TERM AND RENEWAL

The term of the Original Agreement, as amended (which expires on December 31, 2010) shall be extended for a period of five additional years through December 31, 2015.

Prior to the end of this term, the City and Contractor may, by mutual agreement, renew this Amended and Restated Agreement for three (3) additional periods of five (5) years upon such terms and conditions as may be agreed to between the parties and subject to City Commission approval.

All amendments and revisions incorporated by this Amended and Restated Agreement shall become effective immediately upon full execution of the Amended and Restated Agreement.

9. PAYMENTS TO CITY

The parties acknowledge and agree that the payments, as proposed and accepted by the City, shall be firm for the term of the Amended and Restated Agreement. The payments for subsequent terms shall be subject to negotiation between the parties for each extension term and shall reflect the current economic conditions in the City, number of benches or receptacles proposed, and the anticipated revenues from those benches or receptacles for the extension term. Contractor shall submit to the City its proposed adjustments to the payments at least ninety (90) days prior to the expiration of the Agreement term then in effect.

(a) Benches - The Contractor shall pay to the City the annual agreement payment for convenience benches as scheduled below in equal monthly installments paid in advance and paid on or before the first day of each month:

Annual Payments - Convenience Benches:**

2011 - \$87,704.49
2012 - \$90,335.58
2013 - \$93,045.65
2014 - \$95,837.02
2015 - \$98,712.13

****Note:** An estimated 3% increase has been added to each Agreement year and is subject to further adjustment in accordance with the actual Consumer Price Index

If both Parties elect to renew this Amended and Restated Agreement, the annual agreement payment shall be the previous year's amount, adjusted by CPI. Annual CPI increase shall be calculated for each calendar year, commencing January 1, using the previous October's CPI as published by the Bureau of Labor Statistics of the United States Department of Labor and shall not exceed three percent (3%) in any one year. Should the Bureau discontinue the publication of an Index approximating the index contemplated here, then such Index as may be published by another United States governmental agency which most nearly approximates the Index referred to here shall govern and be substituted as the Index to be used, subject to the application of an appropriate conversion factor to be furnished by the governmental agency publishing such Index.

(b) Trash Receptacles - The Contractor shall pay to the City the annual agreement payment for trash receptacles as scheduled below in equal monthly installments paid in advance starting on the effective date of this Amended and Restated Agreement and paid on or before the first day of each month:

Annual payments-trash receptacles:

2011 - \$20,400.00
2012 - \$21,600.00
2013 - \$22,800.00
2014 - \$24,000.00
2015 - \$25,200.00

If both Parties elect to renew or extend this Amended and Restated Agreement for additional terms, payments shall increase a minimum of \$1,200.00, annually, for each additional year of the Agreement.

(c) Gross Receipts - In addition to the above payments, Contractor agrees to pay City an annual override based on gross receipts from the sale of bench advertising pursuant to this Amended and Restated Agreement as follows:

Seventeen percent (17%) of the annual gross receipts above \$250,000 but equal to or less than \$300,000; plus

Fifteen percent (15%) of the annual gross receipts above \$300,000 but equal to or less than \$350,000; plus

Twelve percent (12%) of the annual gross receipts exceeding \$350,000.

For example, if the Contractor's gross receipts are \$329,000 for the first year of the Amended and Restated Agreement, then the override to the City would be seventeen percent (17%) of \$50,000 (\$8,500) plus fifteen percent (15%) of

\$29,000 (\$4,350) for a total override of \$12,850. The override payment shall be submitted with the annual financial statement required in Paragraph 10.

10. RECORDS, ACCOUNTS, AND STATEMENTS

Contractor shall keep at a location within Dade, Palm Beach or Broward County, Florida, approved by City, true, accurate, and complete records and accounts of all advertising sales, expenses, and other business being transacted under this Amended and Restated Agreement throughout the term of the Amended and Restated Agreement, including any option terms, and for three (3) years following its expiration or cancellation.

The Contractor agrees to and shall give City or City's representative access during reasonable business hours and upon three (3) business days' notice to examine and audit such records and accounts. Such records shall be maintained as an independent certified public accountant would need in order to examine the records pursuant to generally accepted auditing standards.

Within sixty (60) days after each fiscal year, Contractor shall deliver to City a written annual financial statement pertaining to their operations under this Amended and Restated Agreement. Said statement shall be prepared in accordance with generally accepted auditing standards and shall be certified as true, accurate and complete by Contractor, by and through a duly authorized independent Certified Public Accountant.

11. REPORTS

The Contractor shall submit to the City a quarterly report within fifteen (15) days of the end of each Amended and Restated Agreement quarter. Each report shall contain the following:

- (a) The location and date of installation of benches and receptacles installed during the prior quarter.
- (b) The location and date of removal of benches and receptacles removed during the prior quarter.
- (c) A listing of all benches and receptacles located within the City, including bench and receptacle identifying numbers and locations at the end of the prior quarter.
- (d) Application for permission to install benches and receptacles during the upcoming quarter. The form of the application to be approved and provided by the City.

All reports, including the annual financial statement, shall be sent to the City's Agreement Coordinator. The form of the report to be developed by the Contractor is subject to the prior approval of the City's Agreement Coordinator.

12. INSURANCE

At all times during the term of this Amended and Restated Agreement, the Contractor, and any approved sub-contractor, at it's sole cost and expense, shall maintain in full force and effect, public liability insurance with coverage as follows:

- (a) Not less than one million dollars (\$1,000,000) for death of, or injury to, any one person in any one occurrence.
- (b) Not less than one million dollars (\$1,000,000) for death of, or injury to, two or more persons in any one occurrence.
- (c) Not less than one million dollars (\$1,000,000) property damage in any one occurrence.

Certificates of such insurance shall be delivered to City prior to the beginning of any operations under the Amended and Restated Agreement; such policies shall name City of Fort Lauderdale as additional insured and shall provide that City's Risk Manager be given at least thirty (30) days advance written notice of cancellation or material modification.

13. INDEMNIFICATION

The Contractor covenants and agrees to indemnify and hold the City harmless for any death of or injury to persons or damage to or loss of property which may occur as a result of the Contractor's performance under this Amended and Restated Agreement. The Contractor also specifically agrees to defend the City in the event any claim is made against the City as a result of any such death, injury or damage, and to pay all costs, judgments and fees, including attorney's fees, which may be incurred by the City as a result of such a claim. If called upon by City, the Contractor shall assume and defend not only itself but also City in connection with any suit or cause of action in connection with such claim, and such defense shall be at no cost or expense whatsoever to City.

14. SUPERVISION OF CONTRACTOR PERFORMANCE

The City Manager shall administer the Amended and Restated Agreement for the City. The City Manager may delegate to other City staff all or a part of the supervision of Contractor's performance under this Amended and Restated Agreement.

15. INDEPENDENT CONTRACTOR

The Contractor is an independent contractor under this Amended and Restated Agreement. Personal services provided by the Contractor shall be by employees of the Contractor and subject to supervision by the Contractor, and not as officers, employees, or agents of the City. Personnel policies, tax responsibilities, social security, health insurance, employee benefits, purchasing policies and other similar administrative procedures applicable to goods and services rendered under this Amended and Restated Agreement shall be those of the Contractor.

It is the intent of the parties that the Contractor's principals or senior management personnel listed in its response to the RFP will be available for the entire initial Original Agreement term. Personnel of equal or higher qualifications may replace such personnel, subject to prior City Manager approval, which shall not be unreasonably withheld. The City acknowledges that Contractor may subcontract all or part of its obligations under this Amended and Restated Agreement to Gold Coast Bench, Inc. Substitution of subcontractors shall be done only with the prior written approval of the City Manager, which approval shall not be unreasonably withheld.

16. UNCONTROLLABLE CIRCUMSTANCES ("Force Majeure")

The City and Contractor will be excused from the performance of their respective obligations under this Amended and Restated Agreement when and to the extent that their performance is delayed or prevented by any circumstances beyond their control including, fire, flood, explosion, strikes or other labor disputes, act of God or public emergency, war, riot, civil commotion, malicious damage, act or omission of any governmental authority, delay or failure or shortage of any type of transportation, equipment, or service from a public utility needed for their performance, provided that:

- (a) The non performing party gives the other party prompt written notice describing the particulars of the Force Majeure including, but not limited to, the nature of the occurrence and its expected duration, and continues to furnish timely reports with respect thereto during the period of the Force Majeure;
- (b) The excuse of performance is of no greater scope and of no longer duration than is required by the Force Majeure;
- (c) No obligations of either party that arose before the Force Majeure causing the excuse of performance are excused as a result of the Force Majeure; and

- (d) The non-performing party uses its best efforts to remedy its inability to perform.

Notwithstanding the above, performance shall not be excused for a period in excess of two (2) months, provided that in extenuating circumstances, the City may excuse performance for a longer term. Economic hardship of the Contractor will not constitute Force Majeure. The term of the Amended and Restated Agreement shall be extended by a period equal to that during which either party's performance is suspended under this provision of the Amended and Restated Agreement.

17. ASSIGNMENT

Neither this Amended and Restated Agreement, nor any portion thereof unless otherwise authorized herein, shall be assigned without the formal consent of the City Commission. No such approval will be construed as making the City a party of or to such assignment, or subjecting the City to liability of any kind to any assignee even if subcontracting is authorized herein. No subcontracting agreement shall, under any circumstances, relieve the Contractor of any liability or obligation under this Amended and Restated Agreement.

18. PERMITS

Contractor shall have the sole responsibility, at its sole cost and expense, to secure all necessary City, Broward County, State and Federal licenses and permits for the installation of the benches and receptacles.

19. CONFORMITY TO LAW

Contractor shall comply with all applicable laws, ordinances, regulations, and orders of federal, state, county and municipal authorities pertaining to Contractor's performance under this Amended and Restated Agreement. The Contractor covenants and agrees that there will be no discrimination as to race, color, creed or national origin in the Contractor's performance of the Amended and Restated Agreement.

20. NOTICES

All notices required by law and by this Amended and Restated Agreement to be given by one party to the other shall be in writing and sent by certified mail, return receipt requested to the parties at the following addresses:

21. DEFAULT

In the event of the breach of any of the covenants of the Amended and Restated Agreement by the Contractor, and such breach is not cured or corrected within thirty (30) days after receipt of written notice of the breach, then the City shall have the right to terminate this Amended and Restated Agreement at the expiration of the thirty (30) day notice.

22. FINAL REPOSITORY

The parties mutually represent and warrant to each other that this Amended and Restated Agreement, consisting of paragraphs 1 through 26, inclusive, constitutes the final repository of the parties on its subject matter and may not be changed, modified, discharged or extended except by written instrument duly executed by the parties. The parties agree that no previous representations or warranties shall be binding upon either party nor has the execution of this Amended and Restated Agreement been induced on the part of any party except as expressed in writing in this Amended and Restated Agreement.

23. INTEREST

All delinquent payments to the City shall bear interest at the rate equivalent to the periodic composite of current annual interest rates on five (5) year United States Government agency issues in effect as of the date of delinquency, but not less than ten per cent (10%) per annum. Such interest shall be calculated from the due date, exclusive of any grace period, to the date of payment, on a daily basis, and will be due and payable when billed.

24. NONWAIVER

Failure of the City to insist upon the strict performance of any of the covenants, conditions and agreements of this Amended and Restated Agreement in any one or more instances, shall not be construed as a waiver or relinquishment in the future of any such covenants, conditions and agreements.

25. INDEMNITY AGAINST COSTS AND CHARGES

In the event of any litigation concerning this Amended and Restated Agreement, the prevailing party shall be entitled to recover from the losing party all reasonable costs and attorneys' fees through all appeals.

26. LITIGATION VENUE

The parties waive the privilege of venue and agree that all litigation between them in the state courts shall take place in Broward County, Florida, and that all litigation between them in the federal courts shall take place in the Southern District in and for the State of Florida.
