Federal Highway Unit 609, Slip #4, for the Installation of a Four-Post Boat

Lift - (Commission District 2)

Recommendation

It is recommended that the City Commission adopt a Resolution granting a Waiver of Limitations for the installation of a four-post boat lift located at 1180 N. Federal Highway Unit 609, Slip #4.

Background

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow mooring structures and mooring pilings to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 (C) of the Unified Land Development Regulations (ULDR) for the installation of a four-post boat lift extending a maximum of +/-30 feet from the property line into the Middle River. The applicant's Summary Description specifies that the proposed boat lift is necessary to protect the owner's vessel as it is adjacent to a water-skiing area.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended unanimous approval of the revised application 11 to 0 at the August 6, 2020 meeting (Exhibit 3).

Resource Impact

There is a positive fiscal impact in the amount of \$1,500.00.
