the Law Firm of Kaplan Kirsch & Rockwell LLP as Special Counsel for Airport Noise Compatibility Issues, 14 CFR Part 150 Airport Noise Compatibility Planning and Metroplex Studies Pertaining to the Fort Lauderdale-Hollywood International Airport – (Commission Districts 1, 2,

3, and 4)

Recommendation

It is recommended that the City Commission authorize an additional expenditure of up to \$50,000 for legal services performed by the law firm of Kaplan Kirsch & Rockwell LLP as special counsel for airport noise compatibility issues, CFR Part 150 Airport Noise Compatibility Planning and Metroplex Studies pertaining to the Fort Lauderdale-Hollywood International Airport.

Background

On January 22, 2019, the City Commission of the City of Fort Lauderdale adopted Resolution No. 19-09, appointing the law firm of Kaplan Kirsch & Rockwell, LLP, as special counsel to represent the City of Fort Lauderdale with general airport matters pertaining to the Fort Lauderdale Executive Airport, and airport noise compatibility issues, CFR Part 150 Airport Noise Compatibility Planning and Metroplex Studies pertaining to the Fort Lauderdale-Hollywood International Airport.

At that time it was anticipated that \$50,000 would be needed for the airport noise compatibility part of the appointment. That amount has been exhausted, and another \$50,000 is needed for continued legal services.

It is recommended that the City Commission authorize the expenditure of up to an additional \$50,000 for legal services performed by the law firm of Kaplan Kirsch & Rockwell LLP as special counsel for airport noise compatibility issues, CFR Part 150 Airport Noise Compatibility Planning and Metroplex Studies pertaining to the Fort Lauderdale-Hollywood International Airport.
