A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE SECOND AMENDMENT TO THE AMENDED AND RESTATED AGREEMENT WITH THE BOYS & GIRLS CLUBS OF BROWARD COUNTY, INC., TO PROVIDE FOR THE INSTALLATION AND MAINTENANCE OF TRASH RECEPTACLES, AUTHORIZE ADVERTISING ON TRASH RECEPTACLES AND BENCHES. ESTABLISH DESIGN STANDARDS FOR TRASH RECEPTACLES, EXTEND THE AGREEMENT. AND AUTHORIZE THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT TO THE AMENDED RESTATED AGREEMENT. **PROVIDING FOR** AND CONFLICTS. PROVIDING SEVERABILITY, AND FOR PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Boys & Girls Clubs of Broward County, Inc. ("Contractor") has provided installation and maintenance services for transit bus benches since 1999; and

WHEREAS, on December 26, 2008, the City of Fort Lauderdale, Florida ("City"), entered into an Amended and Restated Agreement to extend the agreement, among other things; and

WHEREAS, on December 15, 2015, the First Amendment to the Amended and Restated Agreement was authorized by the City Commission, and included provisions on the maintenance of select city-owned bush shelters, trash removal detail, location of bus benches, as well as payment structure and installation of new benches; and

WHEREAS, the City and Contractor wish to amend the agreement to authorize advertising on the benches and trash receptacles, provide for the installation and maintenance of trash receptacles, establish design standards for trash receptacles, and extend the agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The Second Amendment to the Amended and Restated Agreement with the Boys & Girls Clubs of Broward County, Inc. regarding the installation and maintenance of trash receptacles and benches is hereby approved.
