TITLE: Resolution Approving the Second Amendment to the Amended and

Restated Agreement with the Boys & Girls Clubs of Broward County, Inc. to Provide Benches and Trash Receptacles—(Commission Districts 1, 2, 3

and 4)

Recommendation

It is recommended that the City Commission adopt a resolution approving the Second Amendment to the Amended and Restated Agreement with the Boys & Girls Clubs of Broward County, Inc., for the installation and maintenance of benches and trash receptacles, in substantially the form attached, and authorizing the City Manager to execute the Second Amendment, attached in Exhibit 1.

Background

On November 4, 2008 the City Commission entered into the Amended and Restated Agreement (CAM #08-1634) for the installation and maintenance of bus benches. This agreement included the placement of advertising on bus benches and sponsorship plaques on trash receptacles.

The First Amendment to this Agreement was authorized by the City Commission on December 15, 2015 (CAM #15-1573). The Amended and Restated Agreement as amended by First Amendment provides that the City and contractor, by mutual agreement may renew the agreement prior to the expiration. The current term of the Agreement ends on December 31, 2020.

The proposed Second Amendment to the Amended and Restated Agreement includes the following terms:

- Installation of fifty (50) new Superior Public Recycling units ("SRAs") also known as trash receptacles;
- Authorizes advertising on trash receptacles pursuant to the same terms and conditions allowed for bus benches;

- · Specifies design standards for trash receptacles; and
- Extends agreement until December 31, 2025

Resource Impact

The City is paid revenue through the agreement in a lump sum and percentage of gross receipts from the advertising. The revenue generated from the existing benches for advertising is increased annually. The City also receives a percentage of the annual gross receipts. This gross annual overage is based on the following:

- 17% of annual gross receipts between \$250,000 and \$300,000
- 15% of annual gross receipts between \$300,000 and \$350,000
- 12% of annual gross receipts exceeding \$350,000.

In 2019, the City received \$90,874.24 through the existing contract. It is anticipated that the City would receive increasing payments each year with a payment structure along with 25% gross revenue of any new bus benches installed.
