TITLE: Resolution Approving a Fourteenth Amendment to the Maintenance Memorandum of Agreement Inclusive Agreement for State Road A1A with the Florida Department of Transportation for Landscape Improvements Within the Right-of-Way of State Road A1A - **(Commission District 2)**

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Fourteenth Amendment to the Maintenance Memorandum of Agreement inclusive Agreement for State Road A1A with the Florida Department of Transportation for landscape improvements within the right of way of State Road A1A (North Ocean Boulevard) Section 86180000, from Mile Post 2.637 (Seabreeze Boulevard) to Mile Post 2.964 (Las Olas Boulevard) and Section 86050000 from Mile Post 2.042 (Las Olas Boulevard) to Mile Post 2.441 (Alhambra Street).

Background

In January 2008, the City of Fort Lauderdale ("City") entered into a Landscape Inclusive Maintenance Memorandum of Agreement ("MMOA") with the Florida Department of Transportation ("FDOT") for the purpose of the City maintaining the landscape improvements on various roads including State Road A1A. The Fourteenth Amendment includes provisions allowing the City to construct additional landscape improvements or to modify an improvement on State Road A1A from Mile Post 2.637 to Mile Post 2.441, Seabreeze Boulevard to Alhambra Street, and in accordance with the plans attached as Exhibits "A" and "B" to the agreement. These landscape improvements and attached plans are part of the City of Fort Lauderdale Beach Streetscape Improvement Project P11681. Approval of this resolution will allow the proposed landscape improvements to be constructed.

Resource Impact

There is no fiscal impact associated with this action.
