

Usually it takes 1 business day for 1 user role to have a preliminary technical/functional description set. At the same time WorkFlow phases, "Roles" structure with permissions will be defined. We will identify 2-3 functions that can be easily integrated with existing system/process and implement them seamlessly, so users can still work how they used to, giving us feedback on the functions implemented.

It will take us up to 10 days to produce technical documentation for the project.

Implementation of the fully functional pilot will take no more than 180 days. During this period users will comfortably use the platform with new functions added every week, receiving training videos and in app instructions This approach will make the educational process interactive and easy to absorb, dividing and delivering sophisticated system in small parts.

Such an approach let us work on corrections/additional requirements in a timely manner. Receiving feedback to particular feature from all users at the same time.

Based on previous experience, we anticipate another 180 days for additional requirements, not listed in RFP, to arise. Those requirements will be implemented under the same "cost proposal" if they are already incorporated in existing platform, or require minimum configuration.
