TITLE: Motion Approving Increase in Funds to Contract for General Wastewater

Professional Architectural-Engineering Services-CDM Smith, Inc. -

\$57,025 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends for the City Commission to approve an increase in funds and time extension to the contract for General Wastewater Professional Architectural-Engineering Services with CDM Smith, Inc. in the total amount of \$57,025 for a new contract total of \$1,235,448 and to extend the contract end date to May 31, 2021.

Background

On May 3, 2011 the City Commission awarded the General Wastewater Professional Architectural-Engineering Services Contract (RFQ #606-10482) to CDM Smith, Inc. (f/k/a Camp Dresser & McKee, Inc.). This Consulting Competitive Negotiation Act (CCNA) Contract was awarded for a five-year term with the option to renew for two successive two-year terms under the conditions and compensation with a contract cap of \$450,000 per year. The contract's 2nd term extension had an expiration date on May 2, 2020. Per City of Fort Lauderdale Procurement Ordinance Sec. 2-178. Organization. (c), (14) the contract was extended one hundred eighty days with a new expiration date of November 2, 2020 without additional funding.

Public Works staff has identified two project reports listed below that are needed to assist with preparing the FY2021 Capital Improvement Plan budget for the Central Region fund. The project costs for these projects total \$57,025. CDM Smith, Inc. has assisted the City with preparing these reports for more than 10 years and are experts with these types of reports.
