TITLE:	Motion Approving Purchase of Streetlight Fixtures, Annual Contract – Transportation Solutions & Lighting, Inc \$839,090 - ( <b>Commission</b> <b>Districts 1, 2, 3 and 4</b> )

## **Recommendation**

Staff recommends for the City Commission to approve a contract, in substantially the form attached, for the purchase of streetlight fixtures from Transportation Solutions & Lighting, Inc., in the estimated annual amount of \$839,090 and authorize the City Manager to approve three, one-year renewal options, contingent upon appropriation of funds.

#### **Background**

The Parks and Recreation Department uses these streetlight fixtures to maintain current street light fixtures and to replace outdated high-pressure sodium fixtures (HPS) that are still in place in some areas. This contract also includes smart nodes for tracking light outages and failures as well as Florida Fish and Wildlife Commission (FWC) approved amber street light fixtures that can be used along A1A on the barrier island.

The Procurement Services Division issued Invitation to Bid No. 12444-512 and received six bids. Low bidder, Rexel USA, Inc. did not meet bid specifications of freight requirements and has been deemed non-responsive. Second low bidder, Transportation Solutions & Lighting, Inc. has met all specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder. One of the six vendors that responded has indicated its status as a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise.
