The City of Fort Lauderdale will be receiving a second round Coronavirus Relief Fund (CRF) from Florida Housing Finance Corporation for the 2020-2021 fiscal year. Funds will be used to provide residential rental and mortgage assistance for eligible households that reside in the city limits of Fort Lauderdale.

The total award is \$436,500.00 and will be used as follows:

Rental Assistance \$321,025.00  
Mortgage assistance and project delivery fees: \$50,000.00  
Project delivery \$21,825.00  
Program Administration: \$43,650.00

All assisted households must be at or below 120% of the area median income.

The period of performance begins on August 20, 2020 and ends December 2020.

The program will be administered by Housing Foundation of America effective October 30, 2020

The Coronavirus Relief Funds (CRF) Strategy 2 requires public notice be published for 10 days before the beginning of the application period. The ten-days will commence Monday, September 28th, and end on October 9, 2020.
