Executive Airport Runway Incursion Mitigation Project and Motion Authorizing Task Order No. 9 for Revisions to Bid Package Services for the Fort Lauderdale Executive Airport Runway Incursion Mitigation

Project- HDR Engineering, Inc. - \$27,028 - (Commission District 1)

Recommendation

Staff recommends the City Commission reject all bids for Fort Lauderdale Executive Airport Runway Incursion Mitigation Project (Bid number 12416-203) and authorizes a revision to the bid package services task order (Exhibit 1) for the Fort Lauderdale Executive Airport (FXE) Runway Incursion Mitigation project with HDR Engineering, Inc. (HDR) in an amount not to exceed \$27,028.

Background

On June 15, 2020, the Procurement Services Division issued Invitation to Bid No. 12416-203. One bid was received on July 14, 2020. The bid submitted by American Infrastructure Services, in the amount of \$1,339,510.45, is more than ten percent of Engineer of Record's cost estimate. The Federal Aviation Administration (FAA) advised City staff that it is necessary to reduce the scope of the project and rebid the project to receive bids that would meet the grant amount threshold.

To comply, revisions to the original plans and specifications are needed from the Engineer of Record, HDR. Plans and specifications were originally developed at a cost of \$98,418. Staff has negotiated Task Order No. 9 with associated fees with HDR to provide revisions to the original bid package services in the amount not to exceed \$27,028. The task order will consist of conducting airport staff review meetings, revising construction plans, revising construction phasing schedule, electrical plans, disadvantage business enterprise (DBE) support services, revising construction cost estimates, revising bid specifications and assistance during the bidding process. This task order is being entered into, pursuant to the consultant services contract with HDR approved by the City Commission on July 10, 2018 (CAM #18-0676).

Resource Impact

There will be a fiscal impact to the City in the amount of \$27,028 for the task order. Funds for this award, in the amount of \$27,028 are available in the FY 2021 Community Investment Plan in the account listed below.
