TITLE: Resolution Approving and Ratifying a Collective Bargaining Agreement Between the City of Fort Lauderdale and the Fort Lauderdale Professional Firefighters, Inc., International Association of Firefighters (IAFF), AFL-CIO-CLC, Local 765- Battalion Chiefs Effective October 1, 2020 through September 30, 2021 and Authorizing Execution of the Collective Bargaining Agreement - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission adopt a resolution approving and ratifying a Collective Bargaining Agreement between the City of Fort Lauderdale and the Fort Lauderdale Professional Firefighters, Inc., International Association of Fire Firefighters (IAFF), AFL-CIO-CLC, Local 765- Battalion Chiefs effective October 1, 2020 through September 30, 2021.

Background

The previous IAFF Collective Bargaining Agreement for Battalion Chiefs expired on September 30, 2020. The City and the IAFF began negotiations for a successor agreement in July 2020 and met six times. Through these negotiations, the City and the IAFF came to a tentative agreement. The tentative agreement was presented to the IAFF Battalion Chief membership for ratification and the IAFF advised the City that the respective employees voted to ratify the agreement.

Resource Impact

The FY 2021 impact of this agreement is \$138,980. Of this amount, \$18,436 is unbudgeted and is contingent upon the approval of the Consolidated Budget Amendment CAM 20-0688. Exhibit 2 provides details of the significant cost drivers included in the agreement.
