We appreciate you providing us a presentation on October 13, 2020 and have additionally shared the information with our general membership. We would like to provide our support of this application that includes key strategies identified by the neighborhood to improve safety for drivers, pedestrians, and bicyclists by widening bike lanes, adding pedestrian crossings, improving the safety of existing pedestrian crossings, and calming traffic cutting through our neighborhood on NE 15th Avenue.

In terms of priorities, the Roundabout is critically important, and the intersection at Sunrise Blvd and median over the bridge (from Wilton Manors) are both strong contenders for the second level priority. Thereafter, the medians moving from north to south would round out our list of priorities with regards to the project. Finally, and possibly outside the scope of the project, having two digital speedometer signs posted at the northbound and southbound approaches to the roundabout would really allow for the project to improve traffic calming through the neighborhood.
