PLEASE TAKE NOTICE that the City of Fort Lauderdale ("City") is considering a Second amendment to its 2019-2020 Annual Action Plan and its 2015-2019 Consolidated Plan for the City's Community Development Block Grant. The Plans are being amended to incorporate additional resources allocated to the City of Fort Lauderdale under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (Public Law 116-136).

In accordance with the Substantial Change Policy of the City's U.S. Department of Housing and Urban Development (HUD) approved Consolidated Plan, any change in activity as a result of the addition or cancellation of a program or a change in the purpose, scope, location, or beneficiary of an activity or funding allocation, requires a program amendment to the Annual Action Plan and the Consolidated Plan. The City of Fort Lauderdale's program amendment and Substantial Change Policy requires City Commission approval and public input at a public hearing after proper notice has been published for a five-day public comment period as provided by waivers under the CARES Act.
