

**CITY OF FORT LAUDERDALE**  
**COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**  
**AMENDMENT #001 TO THE FY 2019 – 2020 PARTICIPATION AGREEMENT**  
**WITH**

**Center for Independent Living of Broward, Inc. (CIL)**

THIS AMENDMENT, with an effective date of **October 1, 2020** by the City of Fort Lauderdale (also known as the “City”) and CIL (also known as the “Participant”) whose usual place of business is **4800 N. State Road 7, Suite 102, BLDG F, Lauderdale Lakes, FLORIDA 33319**.

WHEREAS, the City receives Community Development Block Grant (“CDBG”) funding from the U.S. Department of Housing and Urban Development (“HUD”) to undertake particular activities, including the provision of youth services to eligible persons under Title I of the Housing and Community Development Act of 1974, as amended (“HCD Act”), Public Law 93-383; and

WHEREAS, the City entered into an Agreement dated October 1, 2019, with the Participant in accordance with the Annual Action Plan approved on **July 9, 2019 through CAM #19-0568** in the amount of \$36,215.00 for its **Independent Living Program**; and

WHEREAS, due to the Coronavirus pandemic the Participant is unable to expend the funds within its original agreement of October 1, 2019 through September 30, 2020; and

WHEREAS, the City desires to amend the Participant’s original agreement to provide additional time for expenditures; and

WHEREAS, the City desires to amend the original agreement to reflect the extended program expenditure deadline of October 1, 2020 through December 31, 2020.

NOW, THEREFORE, both parties mutually agree that the original Agreement is hereby amended as follows:

**A. PART II (TERM AND TIME OF PERFORMANCE)**

The following sentence to Part II of the Participation agreement is updated to reflect the following:

The original amount in the service agreement must be expended by December 31, 2020.

If the Participant fails to meet any of the agreed upon expenditure terms, the City shall not be obligated to provide additional time extensions and the remaining funds will be reprogrammed for other eligible CDBG use.

**B. EFFECT OF AGREEMENT.**

Unless modified herein, all other terms and conditions of the Community Development Block Grant (CDBG) Program Participation Agreement dated **October 1, 2019**, remain unchanged and in full force and effect.

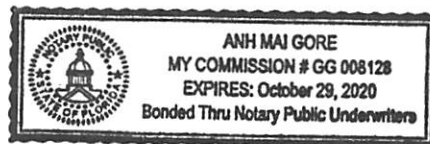

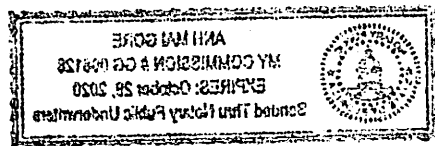


