RESOLUTION NO. 20-230

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DESIGNATING ITS ELECTED OFFICIALS FOR INCLUSION IN THE ELECTED OFFICERS' CLASS OF THE FLORIDA RETIREMENT SYSTEM, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida State Legislature has provided the elected officials of the City of Fort Lauderdale the ability to be included in the Elected Officers' Class of the Florida Retirement System; and

WHEREAS, by Resolution No. 19-117, adopted on June 18, 2019, the City Commission resolved that, "in the event the City of Fort Lauderdale participates in the Florida Retirement System, such participation will encompass the Mayor and City Commissioners of the next City Commission following the November 3, 2020, election"; and

WHEREAS, by Resolution 20-183 adopted on October 6, 2020, the City Commission determined that it is in the best interest of the City and its general employees for all city employees other than police officers and firefighters, including employees of the City of Fort Lauderdale General Employees' Retirement System, the City of Fort Lauderdale Police and Firefighters' Retirement System, and the City of Fort Lauderdale Community Redevelopment Agency, a body politic organized and existing under the Community Redevelopment Act, Part III, Chapter 163, Florida Statutes, (collectively known as "general employees"), to join the Florida Retirement System on January 1, 2021, or soon thereafter as administratively feasible; and

WHEREAS, by Resolution 20-184 adopted on October 6, 2020, the City Commission determined that it is in the best interest of the City and its Mayor and City Commissioners to join the Florida Retirement System on January 1, 2021, or soon thereafter as administratively feasible;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. Designation of Elected Officials: That the Mayor and City Commission of the City of Fort Lauderdale herein designates all its elective positions for inclusion in the Elected Officers' Class of the Florida Retirement System.

<u>SECTION 2</u>. Designation Effective Date: That this designation shall be effective when the city joins the Florida Retirement System on January 1, 2021, or upon the seating of the City Commission following the November 3, 2020, City of Fort Lauderdale municipal election, if later; or as soon thereafter as administratively feasible.

That this Resolution shall be in full force and effect upon final passage. SECTION 3.
