TITLE: Motion Approving a Second Amendment to Subrecipient Agreement
between Broward Metropolitan Planning Organization and the City of Fort
Lauderdale for Downtown Fort Lauderdale Mobility Hub Project -
(Commission District 2)

Recommendation

Staff recommends the City Commission approve a Second Amendment to the Subrecipient Agreement, in substantially the form attached, between the Broward Metropolitan Planning Organization (BMPO) and the City of Fort Lauderdale; execute the agreement to extend the term to April 27, 2021; and amend the initial total grant amount to include the allocation of \$35,000 to the BMPO for contract administration, coordination efforts with the subrecipient, and other contract related activities for the Downtown Fort Lauderdale Mobility Hub Project ("project").

Background

The City and the BMPO entered into a Subrecipient Agreement ("agreement") on February 9, 2017, which approved the acceptance of a grant award of \$3,500,000 for Streetscape Improvements for the project, subject to the Federal Transit Administration's (FTA) grant allocation awarded to the BMPO. Pursuant to Section 11.72.11 of the FTA agreement, the BMPO was allocated \$35,000 of the initial total grant amount, for administering and overseeing the project. Therefore, the actual funding the grant awarded to the City was \$3,465,000.

The First Amendment of the Agreement, dated December 12, 2019, extended the term of the agreement to December 31, 2020. Due to unforeseen delays regarding the project, the City is requesting the approval of a second amendment to the agreement. Proposed amendment will extend the contract term through April 27, 2021, will amend the agreement to reflect the allocation of \$35,000 to the BMPO from the initial total grant amount for administering and overseeing the project, and will memorialize the actual grant awarded to the City in the amount of \$3,465,000.

Resource Impact

The proposed time extension will not result in any additional funds or costs to the City or the Broward Metropolitan Planning Organization. The allocation amendment of \$35,000 is part of the initial total grant amount and does not result in any impact to the City.
