TITLE: Motion Accepting FY2020 Bulletproof Vest Partnership Program Grant -
\$14,039.05 - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve the acceptance of a grant in the amount of \$14,039.05 from the U.S. Department of Justice (DOJ).

Background

In June 2020, the City applied to the United States Department of Justice for funding through their FY 2020 Bulletproof Vest Partnership Program. The grant program provides funding assistance to local law enforcement agencies by reimbursing 50 percent of the cost of eligible vests. In October, the Police Department was awarded grant funds in the amount of \$14,039.05. The grant period is October 1, 2020 through August 31, 2022.

Resource Impact

There is an anticipated positive fiscal impact to the City in the amount of \$14,039.05. The City will meet the grant's required 50% cash match by funding the balance of the cost in the amount of \$14,039.05 via the Police Department's Supply Fund. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 20-0687
