FIRST AMENDMENT TO AGREEMENT FOR COMMUNITY BUS SERVICES BETWEEN THE CITY OF FORT LAUDERDALE AND LIMOUSINES OF SOUTH FLORIDA, INC.

This First Amendment to Agreement for Community Bus Services Between the City of Fort Lauderdale and Limousines of South Florida, Inc. ("First Amendment") is entered into on this 17th day of November, 2020 by and between the City of Fort Lauderdale, Florida (hereinafter "City") and Limousines of South Florida Inc., a Florida corporation, (hereinafter "Contractor"), individually referred to herein as "Contractor" and jointly referred to as "Parties".

WHEREAS, the City of Fort Lauderdale's Risk Management Division has determined that the Garage Liability insurance provision in the Agreement for Community Bus Services Between the City of Fort Lauderdale and Limousines of South Florida, Inc. ("Agreement") is unnecessary, as the Contractor is not and will not store the community buses in its garage; and

WHEREAS, the Parties wish to enter into a First Amendment to the Agreement to remove the Garage Liability insurance provision from the Agreement.

Now, therefore, in consideration of the mutual covenants, promises, and consideration set forth herein, the Parties agree as follows:

1. Exhibit "A" of the Agreement is hereby amended to remove the Garage Liability provision within the Insurance Requirements which states as follows:

Garage Liability

Coverage must be afforded in an amount not less than \$1,000,000 per occurrence and must cover the Contractor and the Contractor's employees for the Contractor's garage and related operations while any and all vehicles covered under this Agreement are in the care, custody, and control of the Contractor.

2. In the event of a conflict between the Agreement and this First Amendment to the Agreement, the terms and conditions of this First Amendment shall prevail.
