TITLE: Second Reading - Ordinance Amending the Code of Ordinances of the City

of Fort Lauderdale, Chapter 9, Building and Construction Fees -

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission consider an amendment to the Code of Ordinances of the City of Fort Lauderdale, Chapter 9, Building and Construction Fees.

Purpose for Building Fee Amendment

On November 5, 2020 the City of Fort Lauderdale adopted Ordinance C-20-36, adopting a new building permit fee schedule. Upon adopting new schedule, Staff noticed that a minor change was not properly captured in Section 9-48 (c)(19). The wording for section currently reads;

Certificate of occupancy (including certificate of occupancy, partial certificate of occupancy, extension of partial certificate of occupancy, temporary certificate of occupancy and extension of temporary certificate of occupancy): four hundred and five dollars (\$405.00). An additional four hundred and five dollars (\$405.00) will be charged for each extension or expansion of Temporary or Partial Certificates of Occupancy.

Amended language proposed is below;

Certificate of occupancy (including certificate of occupancy, partial certificate of occupancy, extension expansion of partial certificate of occupancy, and temporary certificate of occupancy and extension of temporary certificate of occupancy): four hundred and five dollars (\$405.00). An additional four hundred and five dollars (\$405.00) will be charged for each extension or expansion of Temporary or Partial Certificates of Occupancy a partial certificate of occupancy. A fee of one hundred and five dollars (\$105.00) will be charged for an extension of partial certificate of occupancy, or extension of a temporary certificate of occupancy.

The proposed amendment is focused on reducing the fee to extend a partical certificate of occupancy (PCO) or temporary certificate of occupancy (TCO). The extension of a PCO or TCO is an administrative activity and requires no additional plan review or inspection effort.

Resource Impact

The text amendment will have insignificant impact on building services revenue as the core revenue generator for building fees are based on permits issued.
