Carter Park Pool, Croissant Park Water Playground – VPR Construction  
Corporation - \$169,518 - **(Commission Districts 3 and 4)**

**Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the pool resurfacing of Riverland Park Pool, Carter Park Pool, and Croissant Park Water Playground with VPR Construction Corporation, in the amount of \$169,518.

**Background**

Riverland Park Pool, Carter Park Pool, and Croissant Park Water Playground are in need pool surface repairs. Riverland Park Pool has not been resurfaced since 2005, while both Carter Park Pool and Croissant Park Water Playground are showing signs of substantial wear on the surfaces such as cracks, formation of holes in the walls and flooring.

On August 7, 2020, the Procurement Services Division issued Invitation to Bid No. 12413-103. The City received two bids in response to the solicitation, which were opened on September 28, 2020. One of the two vendors that responded indicated its status as a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. All bids were reviewed for compliance with the solicitation specifications. The bid submitted by VPR Construction Corporation has met all the specifications of the solicitation and has been deemed the lowest bidder.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$169,518 for the contract award with allowances included. Funds for proposed agreement in the total amount of \$169,518 are available in the FY 2021 Community Investment Plan in the account listed below.
