Attached are the maps with circles for the Music Series event complying with 8 foot circles - safe distanced 8 feet apart in all directions and indicated on a map of each park. Also included are the calculations of available space in each Park and what is being utilized.

The Music Series will be in both Esplanade Park and in Huizenga Plaza. Calculations are made based on available and only the usable space for this event and where the circles will be located. Circles will be drawn on the ground with an eco-friendly spray paint as prescribed by the City of Fort Lauderdale (for grass safety) and measured on site as they are installed to assure that they are 8 feet apart in all directions.

Kindly advise when we might be able to get an approval. We are 11 days away and need to do our advertising for this to be successful.
