Recommendation

Staff recommends the City Commission approve the acceptance of a grant award in the amount of \$2,000 from the United States Tennis Association (USTA) Florida Section Foundation to supplement equipment cost in providing equipment for the City's Junior Developmental Program.

Background

The United States Tennis Association (USTA) Florida Section Foundation provides grant funding limited to tennis program equipment for programs in the areas of Youth Tennis, Masters Tennis, Adaptive Tennis and Healthy and Active Lifestyles.

The City of Fort Lauderdale's Junior Developmental Program will benefit the community significantly by allowing us the opportunity to expand our program into non-dedicated tennis centers and provide opportunities for children especially of a lower socio-economic status to have reasonable access to equipment and to engage in physical activities through program enrollment.

Resource Impact

This action will result in a positive impact to the City in the amount of \$2,000. No match is required. Appropriation of the funds are contingent upon the approval of the Consolidated Budget Amendment CAM 21-0092.
