TITLE: Motion Accepting a Grant of \$5,662 from the United States Tennis Association (USTA) Florida Section Foundation for Tennis Program Support - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve a motion authorizing the acceptance of a grant award in the amount of \$5,662 from the United States Tennis Association (USTA) Florida Section Foundation to provide Tennis Program Support in the Junior Developmental Tennis Program.

Background

The United States Tennis Association (USTA) Florida Section Foundation provides grant funding for both youth tennis programs and adaptive tennis of special populations and all ages.

The City of Fort Lauderdale's Junior Developmental Program will benefit the community significantly through this grant by allowing an opportunity to expand the program into non-dedicated tennis centers and provide opportunities for children especially of a lower socio-economic status to engage in physical activities through program enrollment. This grant will allow the City to secure certified instructors to provide training and market the program at multiple park sites that offer after-school and community programs in the field of tennis.

Resource Impact

This action will result in a positive impact to the City in the amount of \$5,662. No match is required. Appropriation of the funds are contingent upon the approval of the Consolidated Budget Amendment CAM 21-0092.
