TITLE: Motion Approving Agreement for Prospect Road Wellfield Diesel Tank
Replacement – RC Development Group, Inc. - \$383,001- **(Commission
District 1)**

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with RC Development Group, Inc., for the Prospect Road Wellfield Diesel Tank Replacement project in the amount of \$383,001.

Background

This project scope of proposed agreement includes removal of an existing underground diesel tank and replacing it with a new above-ground diesel tank.

The underground diesel tank fuels the existing generator located in the Prospect Wellfield. The existing tank is damaged and needs to be removed. The project construction will include obtaining all the required permits, removal of the existing underground diesel tank, removal of contaminated soils (if found), and the installation of the new above-ground diesel tank.

On October 30, 2020, the Procurement Services Division issued Invitation to Bid No.12456-613. The City received three bids in response to the solicitation which were opened on December 2, 2020. None of the three vendors are Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. The bid submitted by RC Development Group, Inc. has met all the specifications of the solicitation, and has been deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$383,001 for the agreement award with allowances included, and \$56,999 for estimated in-house project management fees for a total cost of \$440,000. Funds for proposed agreement, in the amount of \$440,000, are available in the FY2021 Community Investment Plan in the accounts listed below.
