A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, PURSUANT SECTION 47-19.3(e) OF THE CITY OF FORT LAUDERDALE, FLORIDA UNIFIED LAND DEVELOPMENT REGULATIONS ("ULDR") GRANTING A WAIVER OF THE LIMITATIONS OF ULDR SECTION 47-19.3(c) TO PERMIT TROY EAKINS AND TAIS EAKINS, INSTALLATION OF A 30,000 LB. PLATFORM BOAT LIFT AND A 5,000 LB. PLATFORM JET SKI LIFT, THAT WILL EXTEND A MAXIMUM OF +/- 34.5 FEET FROM THE PROPERTY LINE INTO THE WATERS OF THE MIDDLE RIVER CANAL, SUCH PROPERTY BEING LOCATED AT 2407 AQUA VISTA BOULEVARD, FORT LAUDERDALE, AND MORE PARTICULARLY DESCRIBED FLORIDA. BELOW; SUBJECT TO CERTAIN TERMS AND CONDITIONS; REPEALING ANY AND ALL PARTS OF RESOLUTIONS IN CONFLICT HEREWITH: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Troy Eakins and Tais Eakins, Husband and Wife (hereinafter "Applicant") own the following described Property located in the City of Fort Lauderdale, Broward County, Florida:

All that part of Lots 1 and 2, of Block 44, re-amended Plat of a part of LAUDERDALE ISLES, as recorded in Plat Book 15, Page 46, of the Public Records of Broward County, Florida, described as follows:

Commence at the Northeast corner of Lot 2 in Block 44, of the said re-amended Plat of LAUDERDALE ISLES; thence run West along the south line of Middle River Canal for a distance of 50 feet; then run Northwesterly along the said South line of Middle River Canal which forms an angle of 17° 08' 14" to the right with a prolongation of the last described course for a distance of 96.31 feet for the Point of Beginning; thence continue Northwesterly along the said South line of Middle River Canal, which is a continuation of the last described course, for a distance of 100.00 feet; thence run Southwesterly along a line which forms an angle of 80° 11' 45" to the left with a prolongation of the last described course for a distance of

162.22 feet to the North line of Aqua Vista Boulevard, thence run Southerly along the said North Line of Aqua Vista Boulevard, which is a curve to the left having a radius of 359.23 feet for an arc distance of 131.33 feet; thence Northeasterly along a line to the Point of Beginning, for a distance of 153.57 feet to the Point of Beginning.

WHEREAS, Applicant is requesting approval for installation of a 30,000 lb. platform boat lift and a 5,000 lb. platform jet ski lift, extending a maximum of +/- 34.5' from the property line into the Middle River Canal, as measured from the Applicant's Property line; and

WHEREAS, the City's Marine Advisory Board on February 4, 2021, reviewed the application for dock waiver filed by the Applicant and voted 8-0 in a roll call vote to recommend approval.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That pursuant to the provisions of Section 47-19.3(e) of the City of Fort Lauderdale, Florida Unified Land Development Regulations (ULDR), the City Commission hereby grants a waiver of the limitations of ULDR Section 47-19.3(c), to allow Applicant to install a 30,000 lb. platform boat lift and a 5,000 lb. platform jet ski lift, extending a maximum of +/-34.5 feet from the Applicant's Property line into the waters of the Middle River Canal, such distances being more specifically set forth in the Table of Distances set forth below:

<u>SECTION 2</u>. That the above waiver is subject to the following additional conditions to be performed by the Applicant:

- 1. The Applicant is required to comply with all applicable building and zoning regulations as well as any other Federal and State laws and permitting requirements including the Broward County Environmental Protection and Growth Management Department, the Florida Department of Environmental Protection and the U.S. Army Corps of Engineers.
- 2. As a general condition of approval and in order to review for final consistency with construction of facilities in accord with this application and City building permits the Applicant is required to provide the City's Supervisor of Marine Facilities with copies of "As Built" drawings from a certified and licensed contractor and verification of all applicable Federal and State permits.
- 3. Use of the upland single family residence and occupation thereof shall be in conformity with the City's ULDR and other applicable municipal, county, state and federal laws, rules, regulations and ordinances, including, but not limited to City Codes, Unified Land Development Regulations and City's Minimum Housing Code, as same may be amended from time to time.
- 4. Maintenance and repair of the vessel moored at this location shall be permitted only in according with City Code § 8-149 and in compliance with City Code of Ordinances, Chapter 17, Noise Control.
- 5. Use of the dock to which the mooring piles are appurtenant shall be limited to the owner or tenant in possession of the upland Property.
- 6. By acceptance of the benefits of this dock waiver, Applicant agrees that the upland Property shall not be leased out as a vacation or short–term rental, where a vacation rental or short-term rental is defined as the leasing out of the upland property with more frequency than twice every three months or the occupation of the upland Property by subtenants that change more frequently than twice every three months.
- 7. Within ninety (90) days of the effective date of this Resolution, Applicant shall file applications for permits for all other governmental or regulatory approvals required to implement the dock waiver herein and provide proof thereof to the Supervisor of Marine Facilities. In the event the Applicant fails to timely file applications for permits as referenced above, the granting of this waiver shall expire, without prejudice to the

Applicant re-filing a subsequent application for dock waivers.

8. The Applicant shall complete construction of the improvements as reflected in the application for the waiver of limitations through to a final certificate of completion no later than 180 days after issuance of all necessary permits. In the event the Applicant fails to timely complete construction of the improvements as referenced above, the granting of this waiver will expire, unless the date for completion of construction is extended by the City Manager upon good cause shown.

- 9. In the event ownership of the Property is transferred to a third party prior to issuance of a building permit to construct the improvements authorized under this dock waiver Resolution, then this Resolution shall become null and void.
- Violation of any of the foregoing conditions is unlawful and constitutes a violation of the City's ULDR and may result in revocation of this Resolution by the City Commission.
- 11. A copy of this Resolution shall be attached to each and every Lease Agreement for the leasing of the Property described herein.
- 12. The Applicant is required to install and affix reflector tape to the proposed mooring piles authorized to extend beyond the limitations provided in ULDR Section 47-19.3(d). The reflector tape must be formulated for marine use and be in one (1) of the following uniform colors: international orange or iridescent silver. On all such piles, the reflector tape shall be at least five (5) inches wide and within eighteen (18) inches of the top of the pile.
- 13. No improvements may be constructed or installed pursuant to this Resolution until after the effective date hereof.
- 14. The vessel shall not be berthed in such a manner as to extend beyond the extension of the side yard setback lines as set forth in ULDR Section 47-19.3(h).

<u>SECTION 3</u>. That all Resolutions or parts of Resolutions in conflict with this Resolution are hereby repealed.

<u>SECTION 4</u>. That this Resolution shall be effective upon (i) Applicant, at Applicant's expense, recording a certified copy of this Resolution and (ii) filing a copy of the recorded Resolution with the Supervisor of Marine Facilities and City Clerk within ninety (90) days of the adoption of this Resolution. Failure to timely meet the conditions of (i) and (ii) shall cause this
