Hard Rock Stadium

Hard Rock Stadium has the GBAC Accreditation and we are excited to be hosting the Dolphins Challenge Cancer Ride and 5K at Hard Rock!

Hard Rock Stadium has established and maintains a cleaning, disinfecting and infectious disease prevention program to control and minimize risk that will set the initial guidelines for our event.

General Guide

We are ensuring all venues and various staffing entities have physical distancing measures in place per the current social standard. Throughout our events and programs we will meet or exceed state and local health authority guidelines on proper protocol.

1. General Mass Gathering Suggested Practices

- 1. Actions will be guided by Local Officials and Health Officers
- 2. Screening of every Team Member (employee) daily leading up to event day
- 3. Face Masks will be required at all times unless eating/drinking.
- 4. Setting limits on participation and guest attendance to naturally increase social distancing
- 5. Reconfiguring queues to ensure social distancing in all directions
- 2. **Queuing.** Any area where guests or employees queue will be clearly marked for appropriate physical distancing. When possible, items and check-in procedures will focus on digital check-ins and/or will be mailed to the individual advance.
- 3. **Check-in Areas and Registration.** Staff will appropriately space out workstations to ensure separation between employees whenever possible.
- 4. Food and Beverage. Only prepackaged, recovery amenities will be provided. Subject to change.
- 5. **Back of the House.** Physical distancing protocols will be used in staging and controlling areas such as breakrooms, storages, tents, and other high-density areas in order to ensure appropriate distancing between employees.

6. Cleaning & Sanitizing Protocol

- All employees to be provided personal size hand sanitizer and wipes to keep on them during their shifts and while on the course
- Employees must wash hands or sanitize hands before and after touching any guest equipment (if support is required)
- Make cleaning visible to guests to help them feel safe
- Enhance the overnight cleaning and sanitize all surfaces throughout the day
- Hand sanitizer stations will be placed throughout event space and entry to promote all guests actively using.

7. Parking

- We will be parking all cars within social distancing guidelines.
- All cars will be parked every other space to make sure adequate spacing between vehicles.

8. Entrance

• At the entrance to the pre-start area, we will be conducting required temperature tests for all participants. Any participant with a temperature of 100.4 degrees Fahrenheit or higher will be asked to step aside to allow for their temperature to come down. After a few minutes, the participant will be re-tested. If the participant's temperature does not read below 100.4 degrees, they will not be allowed to enter the pre-start area or to participate in the event.

• Additionally, Guest Experience will verify all participants have completed the Covid Questionaire that will be shared prior and QR code will be displayed at entrance for completion. A verified email or text will be sent to everyone who has completed the questionnaire.

Administration/Registration/General

To allow for a faster flow of rider/runner item distribution, the following steps will be implemented:

- Less customization of rider or runner number to ease pick up
- Assign # on site as they arrive for pick up (for those that register week of the event)
- 'I Fight For' will be virtual
- Closing registration 1 week prior to allow for all items to be customized, packed, stored, and untouched prior to pick up

Packet and Benefits Pick Up

Along with all the procedures set in place in this document, packet pick up we follow these other guidelines:

- We will conduct the pick up process outdoors or in a very large footprint indoors
- Offer one week to collect your participation items
- Designated pick up time for packets all participants will receive a window during our designated pick up times for pick up
- We will not be conducting any other programming during the pick up
- Riders will also receive a ticket with desired pace for the ride, allowing for us to pre set corral capacities for the following day


DCC Ride

Physical distancing guide steps will be implemented. All staff and volunteers will receive training on COVID-19 safety and sanitation protocols. Additional preventative action items per area include:

Rider corrals will have a maximum of 80 riders per.

Start Lines

- Corralling will be implemented to allow more space per wave; pace cars will be placed at the front of each designated corral
- Corrals will be designed to have 6' of space per rider as show on the diagram to the right
- Riders must have pace card received at packet pick up to end appropriate corral
- Riders/Runners will not be permitted to enter corrals earlier than 5 to 10 minutes prior to their assigned start time.
- Start line chute will be 300 feet long to accommodate riders in each group with appropriated distancing
- Correct frequent handwashing and hygiene will be enforced; gloves will be enforced with all staff near F&B
- Use disinfecting wipes to sanitize all surfaces and items
- Provide contactless experience from parking to start of ride
 - No packets will be distributed at the start line (all riders must collect items at Hard Rock Stadium)
 - Provide sufficient bike racks so all riders have a place to rack bike (limit to 6 bikes per rack)
- Provide prepackaged, untouched food and beverage




- No cups will be provided
- Provide packaged utensils
- Additional portolets, hand wash stations and sanitizing stations will be offered.

• Water Stops

- Capacity 80 people maximum will be allowed at a water stop at one time
- o Correct frequent handwashing and hygiene will be enforced; gloves will be enforced for staff
- Sanitize all surfaces and items as frequent as possible including bike racks/portos after each group
- Provide contactless experience from arrival at stop to departure
 - Provide sufficient bike racks so all riders have a place to rack bike (limit to 6 bikes per rack)
 - Provide prepackaged, untouched food and beverage
 - No cups will be provided
 - Provide packaged utensils/napkins
- Additional portolets, hand wash stations and sanitizing stations will be offered.
- Portolet doors will face opposite directions to allow for 6' of distancing
- Sample water stop layout below:



Finish Line

- Provide ready to drink hydration
- No medals with be given to limit physical contact (Subject to change.)
- o Only medical team and appropriate staff will be allowed in the finish chute
- Bike parking
 - Provide sufficient bike racks so all riders have a place to rack bike (limit to 6 bikes per rack)

• Finish Festival

o Tent capacity will be determined once layout is finalized

- No spectators or friends/family will be allowed at the event
- Furniture will be limited to 42" tall banquet style tables
- Seating will be provided and spread out accordingly
- No recovery massaged
- Provide prepackaged OR served buffet. Subject to change.
 - Provide packaged utensils
- Sponsor activations will be evaluated based on activation type (evaluated every 15 days to until March 25th)
- o Due to potential limited activations some enhancements will be considered:
 - Entertainment: Bring in elevated performances for the duration of finish festival
 - Visual Experience: Provide an elevated visual experience with enhanced decorations, flowers, screens, etc

Kids Zone

o No kids zone to limit contact

• Transportation

o If transportation is offered, we will implement all rules

• Merchandise

- Providing a limited inventory displayed for all to see and select from without touching physical items
- Cashless transactions

Gear Storage

o If we provide gear storage, private mobile lockers will be used.

Alternate Ride Formats

In the case we are not able to accomplish a full event, alternate formats include:

- Heavy Hitter ONLY Ride (max capacity 400 participants)
- Less Route Options
- Host a ride with stationary bikes at Hard Rock Stadium
- Fundraising thresholds (per company) Hosting private ride

DCC 5K

DCC 5K will follow all rules and procedures listed in this document. Further clarifications for any area are listed below.

Start Lines

The start will have a designated start/open time and then remain open for pre-determine window. Runners/walkers can complete the closed 5K course during the pre-determined window.

The first mass of runners will be divided in waves of smaller groups to comply with social distancing.

Families can remain together.

Water Stations

We will have limited water stops on the course, participants will be encouraged to bring their own hydration.

Hard Rock Stadium Statement

Hard Rock Stadium ("HRS") acknowledges the significant impact that COVID-19 has had on the health and safety of people worldwide.
