TITLE: Motion Approving Agreements for Purchase of Plan Review and Inspection

Services - C.A.P. Government, Inc. and Calvin, Giordano & Associates,

Inc. - \$6,000,000- (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve two (2) two-year agreements, in substantially the forms attached, for the purchase of plan review and inspection services, with C.A.P. Government, Inc. ("CAP") and Calvin, Giordano & Associates, Inc. ("CGA") in the estimated amount of \$6,000,000 and authorize the City Manager to approve one (1), two-year renewal option, contingent upon appropriation of funds.

Background

Building permit application activity at the Building Services Division is higher than normal, when compared to other local municipalities. This year, the construction value of projects should exceed \$800 million in total capital investment, with permit applications activity increasing at an average of 6% per year. The forecast is an indication that not only is development continued to grow in the current economic climate, but so has the associated amount of review and inspection time necessary for larger valued projects. To account for the increase in permit volume, the division will continue to supplement City staff using contract services for building permit inspection and plan examination services.

On January 13, 2021, the Procurement Services Division issued Invitation to Bid No. 12376-813. The City received four bids in response to the solicitation, which were opened on February 10, 2021. None of the vendors that responded indicated their status as a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. All bids were reviewed for compliance with the solicitation specifications. The bids submitted by CAP and CGA have met all the specifications of the solicitation and have been deemed the lowest responsive, responsible bidders.

Resource Impact

There will be a current impact to the City in the amount of \$652,751. Future expenditures are contingent upon approval and appropriation of the annual budget.
