Recommendation

Staff recommends the City Commission approve the acceptance of a grant in the amount of \$60,000 from the Florida Department of Transportation (FDOT) for traffic safety programs.

Background

In February 2020, the City submitted an application to FDOT in response to a solicitation for proposals from law enforcement agencies to address the most significant traffic safety issues within their jurisdictions. This City has been awarded \$60,000 in funding to institute a traffic safety program to reduce the frequency of incidents involving occupant protection violations. Education and enforcement activities will focus on improving safety belt and child restraint awareness in areas with the highest volume of violations. Program activities must end on or before September 30, 2021.

Resource Impact

There is an anticipated fiscal impact to the City in the amount of \$60,000. The grant does not require matching funds. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 21-0093.
