

RESOLUTION NO. 21-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, SUPPORTING AND ENDORSING THE PLAN OF TWENTY CYCLE TWO TRANSPORTATION SURTAX MOBILITY ADVANCEMENT PROGRAM CAPITAL PROJECTS IN THE CITY OF FORT LAUDERDALE, FLORIDA, AS IDENTIFIED IN EXHIBIT 1, AUTHORIZING SUBMISSION OF FUNDING APPLICATIONS TO THE BROWARD COUNTY TRANSPORTATION SURTAX MOBILITY ADVANCEMENT PROGRAM IN ORDER TO IMPLEMENT THE PROJECTS, AND PROVIDING FOR SEVERABILITY, RESCISSION OF CONFLICTING RESOLUTION PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, on September 25, 2018, the City Commission adopted Resolution No. 18-200, approving and authorizing execution of a revised Transportation System Surtax Interlocal Agreement with Broward County, a political subdivision of the State of Florida, *et al.*, which provided for a cooperative and organized process for the municipality signatories to submit projects for evaluation and funding with Transportation System Surtax proceeds; and

WHEREAS, on November 6, 2018, the electors of Broward County, Florida, approved a local one percent discretionary sales surtax for thirty-years to increase mobility and address transportation challenges in Broward County; and

WHEREAS, on July 9, 2019, the City Commission adopted Resolution No. 19-135, approving and authorizing execution of a First Amendment to Transportation System Surtax Interlocal Agreement ; and

WHEREAS, on January 21, 2021, the City Commission adopted Resolution No. 21-14, approving a Second Amendment to and Restatement of the Transportation Surtax Interlocal Agreement; and

WHEREAS, the Broward Metropolitan Planning Organization and Broward County have released the schedule for the next cycle of applications for new capital projects to be considered for transportation surtax funding; and

WHEREAS, a resolution from the City of Fort Lauderdale City Commission stating support for the projects is required to establish funding eligibility with Surtax dollars; and

WHEREAS, the members of the City Commission feel that it is in the best interest of the citizens of the City of Fort Lauderdale, Florida, to endorse the proposed new municipal capital projects enumerated in Exhibit 1 (“Projects”) and submit funding applications to Broward County’s Transportation Surtax Fund for Cycle Two in order to obtain funding for the Projects; and

WHEREAS, the City of Fort Lauderdale commits to administer and deliver the Projects under the terms of the Surtax Project Funding Agreements and Broward County Code of Ordinances; and

WHEREAS, the Projects will be constructed within the City of Fort Lauderdale’s rights-of-way or within another government agency’s rights-of-way with proper permission or agreements in place; and

WHEREAS, it is the responsibility of the City of Fort Lauderdale to maintain or coordinate the maintenance of the Projects after their completion;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City of Fort Lauderdale hereby supports and endorses the projects identified in Exhibit 1 of City Commission Agenda Memo 21-0411, a copy of which is attached hereto as Exhibit 1 and incorporated herein, will provide technical assistance when available and needed for the duration of the Projects, and authorizes submission of funding applications to the Broward County Transportation Surtax Mobility Advancement Program in order to implement the Projects.

SECTION 2. That if any clause, section or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 3. That all resolutions or parts of resolutions in conflict herewith are hereby rescinded.

SECTION 4. That this Resolution shall be in full force and effect upon final passage.
