We are respectfully contacting you regarding our application for a Revocable License Agreement submitted to the City of Fort Lauderdale. The City has approved the Site plan for the proposed residential property located at 351 NW 17th Street, Fort Lauderdale. The Revocable license agreement would allow an estimated 3 phased R/W closure projected to last approximately 15 weeks in Total.

- Phase #1 – 24 days proposed to close NW 6th Ave. (actual dates subject to Commission Approval starting as soon as possible)
- Phase #2 – 59 days proposed to close NW 17th Street (actual dates subject to Commission Approval starting as soon as possible)
- Phase #3 – 9 days proposed to close NW 3rd Ave. (actual dates subject to Commission approval starting as soon as possible)

The contracted work will be conducted within the portion of Right of way in front of your property in the coming months. As a part of this permit we will be making improvements to the drainage system among other enhancements within the public right of way which will require temporary closure of the 3 phased areas (as noted above). This letter serves as to make you aware of the planned improvements. We are prepared to provide parking at our property located at 351 NW 17th street during this closure in order to accommodate you should the need arise. 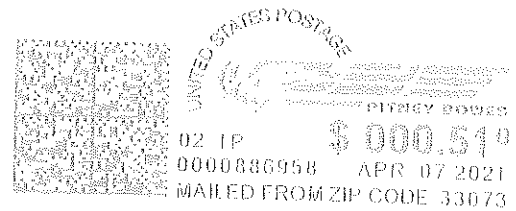

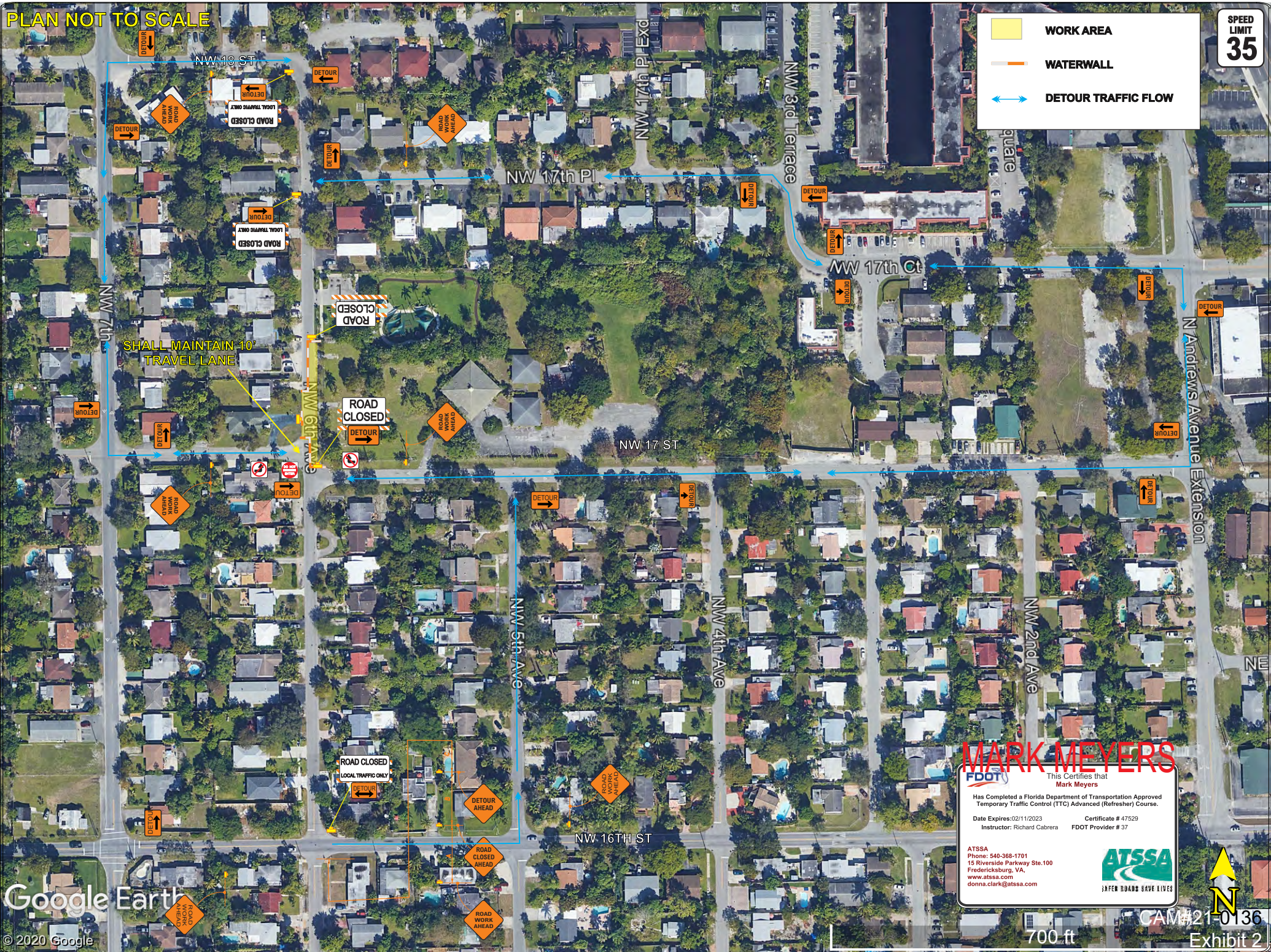
