Dear Trisha:

Pursuant to the City of Fort Lauderdale Ordinance Nos. C-15-01 and C-19-17, the applicant held a public participation meeting to present the Project. The applicant communicated and noticed the public participation meeting through mail notice to all residents within 300' of the Project. An affidavit regarding the meeting notice to all residents within 300' of the Project is enclosed with this letter.

Due to COVID-19, the public participation meeting was held virtually via Zoom on Monday, November 23, 2020 from 5:30PM to 6:30PM. The applicant sent notice of the public participation meeting to all property owners within 300' of the Project as well as to the presidents of the Colee Hammock and Beverly Heights Civic Associations. There were approximately 13 people in attendance. At the meeting the applicant presented the Project, showed plans and renderings of the Project, and addressed questions from the public. A list of the questions, answers, and comments generated at the public meeting is attached hereto as **Exhibit "A"**.

Questions and Answers from Public Participation Meeting

Question: How tall is the building going to be?

Answer: 9 stories, approximately 86 feet.

Question: Where is the parking located?

Answer: The parking will be located underground (below grade).

Question: Will SE 2nd Street be wider than it is today?

Answer: No, but we will be improving the streetscape.

Question: Where will the service trucks load and unload? We don't want trucks lining up on the streets.

Answer: All loading and unloading will be conducted on-site within the footprint of the building.

Question: What will the rates for the hotel be?

Answer: That hasn't been determined yet, but it will be upscale hotel rates.

Question: What is the proposed start and end date for construction?

Answer: We're hoping to start construction in 2021. The end date will be approximately 2 years after construction begins.

Question: Will you be closing any streets during construction?

Answer: SE 2nd Street will remain open except for when it needs to be closed in order to construct the streetscape or resurface the road. SE 10th Terrace will likely be closed during the term of construction to regrade and narrow the street, construct the streetscape, and for safety reasons.

Question: The underground parking is great, but where will the cars be going in and out of?

Answer: The hotel will have a one-way in on SE 2nd Street and a one-way out on SE 10th terrace.

Question: How many hotel rooms and how many parking spaces?

Answer: There will be 134 hotel rooms and 73 parking spaces. We collected data for other hotels and this parking ratio is consistent with what other hotels see for parking. We don't have any meeting space in this hotel, which generates additional traffic.

Question: Are you planning to open the parking to the general public or just guests of the hotel?

Answer: Just guests of the hotel.

Question: Will there be a rooftop bar?

Answer: There will be a small café for guests at the pool. There is a restaurant on the 2nd floor.

Question: Where is the customer entrance to the hotel?

Answer: The lobby on 10th Terrace.

Question: Can you please send this presentation via email?

Answer: Yes, absolutely.

Page 3: Sign Notification Requirements and Affidavit

SIGN NOTICE

Applicant must **POST SIGNS** (for Planning and Zoning Board and City Commission Hearings) according to Sec. 47-27.4.

- Sign Notice shall be given by the applicant by posting a sign provided by the City stating the time, date and place of the Public Hearing on such matter on the property which is the subject of an application for a development permit. If more than one (1) public hearing is held on a matter, the date, time and place shall be stated on the sign or changed as applicable.
- The sign shall be posted at least fifteen (15) days prior to the date of the public hearing.
- The sign shall be visible from adjacent rights-of-way, including waterways, but excepting alleys.
- If the subject property is on more than one (1) right-of-way, as described above, a sign shall be posted facing each right-of-way.
- If the applicant is not the owner of the property that is subject of the application, the applicant shall post the sign on or as near to the subject property as possible subject to the permission of the owner of the property where the sign is located or, in a location in the right-of-way if approved by the City.
- Development applications for more than one (1) contiguous development site shall be required to have sign notice by posting one (1) sign in each geographic direction, (north, south, east and west) on the public right-of-way at the perimeter of the area under consideration.
- If the sign is destroyed or removed from the property, the applicant is responsible for obtaining another sign from the City and posting the sign on the property.
- The sign shall remain on the property until final disposition of the application. This shall include any deferral, rehearing, appeal, request for review or hearings by another body. The sign information shall be changed as above to reflect any new dates.
