TITLE: Motion Approving an Amendment to the Parking Enforcement Agreement
with First Presbyterian Church of Fort Lauderdale, Florida, Inc., located at
401 SE 15th Avenue - **(Commission District 4)**

Recommendation

Staff recommends the City Commission approve a motion authorizing the City Manager to execute an amendment to the parking enforcement agreement with First Presbyterian Church of Fort Lauderdale, Florida, Inc., to monitor and enforce parking an additional parcel located at Tarpon Drive.

Background

On August 18, 2020, City Commission approved a three-year Parking Enforcement Agreement with First Presbyterian Church of Fort Lauderdale, Inc. The current agreement provides the City the ability to perform parking enforcement services for the First Presbyterian Church of Fort Lauderdale, Inc, on three parcels located on the corner of East Las Olas Boulevard and Tarpon Drive.

The proposed amendment will incorporate an additional parcel to be included into the Parking Enforcement Agreement as the First Presbyterian Church rezoned parcel 504211011930 and a portion of 054211011940 located on Tarpon Drive.

The enforcement services provided by the City for the additional parcel will serve as a legitimate municipal purpose with the City retaining all citation revenue derived by parking enforcement actions.

Resource Impact

There is a positive fiscal impact to the Parking Fund in the amount of \$2,280 for FY2021 associated with this action. In future years, the anticipated positive annual impact is \$6,840.
