Recommendation

Staff recommends the City Commission approve a motion authorizing the City Manager to execute a five-year parking enforcement agreement, in substantially the form attached, with Las Olas Place II, LLC for the parking garage located at 1200 East Las Olas Boulevard.

Background

The proposed agreement provides the City the ability to perform parking enforcement services for the Las Olas Place II, LLC. The Las Olas Place II, LLC is a 50,756 square foot office building, located at 1200 East Las Olas Boulevard. The building includes a garage with 272 parking spaces and offers 24-hour parking access for the general public. The City has performed parking enforcement services for Las Olas Place II, LLC since April 14, 2015.

The proposed enforcement agreement will be for a period of five years. The City will enforce all City parking ordinances within this parking facility pursuant to Chapter 26 of the Code of Ordinances of the City of Fort Lauderdale and in accordance with the terms and conditions set forth in this agreement. The enforcement services provided by the City will serve as a legitimate municipal purpose, with the City retaining all citation revenue derived by parking enforcement actions.

Resource Impact

There is a positive fiscal impact to the Parking Fund in the amount of \$5,250 for FY2021 associated with this action. In future years, staff anticipates a positive annual impact in the amount of \$12,600.
