TITLE: Motion Approving a Parking Enforcement Agreement with First Baptist Church of Ft. Lauderdale, Inc. located at 301 East Broward Boulevard -
(Commission District 2)

Recommendation

Staff recommends the City Commission approve a motion authorizing the City Manager to execute a five-year, parking enforcement agreement, in substantially the form attached, with First Baptist Church for the parking lot located at 501 NE 1st Street and 301 East Broward Boulevard.

Background

The proposed agreement provides the City the ability to perform parking enforcement services for the First Baptist Church. The surface parking lot has 209 parking spaces and offers 24-hour parking access for the general public. The City has performed parking enforcement services for First Baptist Church since April 17, 2018.

This enforcement agreement will be for a period of five (5) years. The City will enforce all City parking ordinances within the described lot pursuant to Chapter 26 of the Code of Ordinances of the City of Fort Lauderdale and in accordance with the terms and conditions set forth in this agreement. The enforcement services provided by the City will serve as a legitimate municipal purpose, with the City retaining all citation revenue derived by parking enforcement actions.

Resource Impact

There is an anticipated positive fiscal impact to the Parking Fund in the amount of \$1,389 for FY2021 associated with this action. In future years, staff anticipates a positive annual impact in the amount of \$3,334.
