TITLE: Resolution Approving Third Amendment to the Interlocal Agreement
between Broward County and City of Fort Lauderdale For Community
Shuttle Service – **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends that the City Commission approve a resolution approving the Third Amendment to the Interlocal Agreement (ILA) between Broward County (County) and City of Fort Lauderdale (City) for Community Shuttle Service, in substantially the form attached, and authorize the City Manager to execute the Third Amendment.

Background

On July 7, 2020, the City Commission supported recommendations, presented by City staff, to replace the Community Shuttle Service's ageing fleet with new cutaway vehicles, through a lease from the County. The new cutaway vehicles were transferred to the City on April 13, 2021.

Additionally, on February 2, 2021, the City Commission approved a resolution that allowed the City to enter into a multi-year agreement with Limousines of South Florida, Inc. to temporarily operate and maintain the City's Community Shuttle Service. Described agreement increases the hourly service rate reimbursable by the County from \$44.00 to \$49.90.

To ensure that proposed changes are consistent with the County-City ILA for Community Shuttle service, staff recommends the amendment to the following exhibits of the ILA:

- Exhibit "D" – Vehicle and Equipment Inventory
- Revised Exhibit "F" – Allocated Funding for the City of Fort Lauderdale

Resource Impact

There will be a fiscal impact to the City's Transportation and Mobility budget of \$80 annually for the lease of eight vehicles at \$10 each.
