RESOLUTION NO. 21-79

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERDALE. FLORIDA. AUTHORIZING ACCEPTANCE OF GRANT FUNDS FROM THE FEDERAL AVIATION ADMINISTRATION IN THE AMOUNT OF UP TO \$57,000.00 FOR THE FORT LAUDERDALE EXECUTIVE AIRPORT IN ACCORDANCE WITH THE CORONAVIRUS RELIEF SUPPLEMENTAL RESPONSE AND (CRRSA) ACT AND **AIRPORT** APPROPRIATIONS CORONAVIRUS RESPONSE GRANT PROGRAM (ACRGP) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT WITH THE FEDERAL AVIATION ADMINISTRATION TO ACCEPT SUCH GRANT FUNDING: GRANT NUMBER 3-12-0024-035-2021 AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Grant is provided in accordance with the Coronavirus Response and Relief Supplemental Appropriations ("CRRSA") Act and Airport Coronavirus Response Grant Program ("ACRGP") to provide funding for costs related to operations, personnel, cleaning, sanitization, janitorial services, combating the spread of pathogens at the airport, and debt service payments; and

WHEREAS, the grant funds may be used for the airport's operational and maintenance expenses incurred no earlier than January 20, 2020 or to reimburse debt service payments where such payments occurred on or after December 27, 2020; and

WHEREAS, the FAA has agreed to provide the City of Fort Lauderdale with fifty-seven thousand dollars and 00/100 cents (\$57,000.00) in grant funds for the Fort Lauderdale Executive Airport; and

WHEREAS, at its meeting on April 22, 2021, the Aviation Advisory Board supported staff's recommendation to accept this grant; and

WHEREAS, the City Commission finds that authorizing the execution of the ACRGP Grant Agreement and acceptance of the grant funds is in the best interest of the City of Fort Lauderdale;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Manager is hereby authorized to accept grant funds on behalf of the City of Fort Lauderdale, Florida, from the Federal Aviation Administration in the amount of up to fifty-seven thousand dollars and 00/100 cents (\$57,000.00).

<u>SECTION 2</u>. That the City Manager is hereby authorized to execute the Grant Agreement on behalf of the City of Fort Lauderdale, Florida, with the Federal Aviation Administration in accordance with the Coronavirus Response and Relief Supplemental Appropriations Act and Airport Coronavirus Response Grant Program; Grant Number 3-12-0024-035-2021.

<u>SECTION 3</u>. That the Office of the City Attorney shall review and approve as to form all documents prior to their execution by proper City officials.

SECTION 4. That this Resolution shall be in full force and effect upon final passage and adoption.
