The purpose of this Amendment is to renew this Contract for one year. These changes are made pursuant to section III., A., 2., of this Contract.

THIS AMENDMENT, entered into between the **STATE OF FLORIDA, DEPARTMENT OF JUVENILE JUSTICE**, ("Department") and **CITY OF FORT LAUDERDALE** ("Provider"), amends the above-referenced Contract by deleting, as indicated by "~~strike through~~" or reference and adding, as indicated by "underscore" or reference the section(s) below:
