Other Post-Employment Benefits Trust Quarterly Investment Report for Period Ending December 31, 2020 - (Commission Districts 1, 2, 3 and 4)

Susan Grant, Finance Department Director, gave an overview of the Other Post-Employment Benefit (OPEB) Fund. For the quarter ending December 31, 2020, the OPEB Fund earned 8.77%. For the trailing twelve (12) months, the OPEB Fund earned 12.66%, exceeding the 7% assumed rate of return.

In response to Chair Trantalis' question regarding use of the differential, Ms. Grant explained earnings go to pay unfunded plan liabilities and plan benefits. Enough funds have been accumulated to pay plan benefits out of the OPEB Fund versus the General Fund or the Water and Sewer Fund.

In response to Commissioner Sorensen's question regarding the amount of the unfunded liability, Ms. Grant confirmed she would provide the Commission with this information tomorrow via email.
