

RESOLUTION NO. 21-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A SIXTEENTH (16<sup>TH</sup>) AMENDMENT TO THE LANDSCAPE INCLUSIVE MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE INSTALLATION AND MAINTENANCE OF LANDSCAPE IMPROVEMENTS WITHIN THE RIGHT-OF-WAY OF STATE ROAD A1A, BETWEEN MILE POST 2.736 TO MILE POST 2.784 AND STATE ROAD A1A BETWEEN MILE POST 0.673 TO MILE POST 0.731, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SIXTEENTH (16<sup>TH</sup>) AMENDMENT TO THE LANDSCAPE INCLUSIVE MAINTENANCE MEMORANDUM OF AGREEMENT AND PROVIDING FOR CONFLICTS AND AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale, Florida ("City") and the Florida Department of Transportation ("FDOT") entered into the Landscape Inclusive Maintenance Memorandum of Agreement ("MMOA") on January 31, 2008; and

WHEREAS, the City wishes to enter into a Sixteenth (16<sup>th</sup>) Amendment to the MMOA with FDOT for installation and maintenance of landscape improvements within the right-of-way on State Road A1A (Fort Lauderdale Beach Boulevard), between Mile Post 2.736 to Mile Post 2.784 and State Road A1A (Seabreeze Boulevard) between Mile Post 0.673 to Mile Post 0.731; and

WHEREAS, the landscape improvements will be installed in accordance with the plans and specifications attached as Exhibits "A" and "B" of the MMOA; and

WHEREAS, because State Road A1A is an FDOT right-of-way, authorization for this work must be permitted by FDOT; and

WHEREAS, FDOT requires municipalities to enter into a Landscape Inclusive Maintenance Memorandum of Agreement for the maintenance of landscape improvements;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Sixteenth (16<sup>th</sup>) Amendment to the Landscape Inclusive Maintenance Memorandum of Agreement between the City of Fort Lauderdale, Florida, and the Florida Department of Transportation for the installation and maintenance of landscape improvements within the right-of-way on State Road A1A (Fort Lauderdale Beach Boulevard), between Mile Post 2.736 to Mile Post 2.784 and State Road A1A (Seabreeze Boulevard) between Mile Post 0.673 to Mile Post 0.731, is hereby approved.

SECTION 2. That the City Manager is hereby authorized to execute the Sixteenth (16<sup>th</sup>) Amendment to the Landscape Inclusive Maintenance Memorandum of Agreement.

SECTION 3. The Office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 4. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. That this Resolution shall be in full force and effect upon final passage.
