TITLE: Motion Approving the Increase in Funds to the Structural Bridge

Engineering Consulting Services Contract - (Commission Districts 1, 2, 3

and 4)

Recommendation

Staff recommends the City Commission approve an increase in the value of the Structural Bridge Engineering Consulting Services, increasing the cap value by \$209,759 for a new contract total value \$609,759.

Background

On August 18, 2020, the City Commission awarded the Structural Bridge Engineering Consulting Services Contract (Solicitation No. 1222-496) valued at \$100,000 each, to three consultants: Lakes Engineering, Inc., Hardesty & Hanover, LLC, and TranSystems Corporation dba TranSystems Corporation Consultants for a total combined value of \$300,000 (CAM 20-0548). On January 21, 2021, the City Commission awarded an additional consultant from the initial solicitation, Stantec Consulting Services, Inc., (CAM 21-0067). This increased the contract value by \$100,000, bringing the total value of the contract in aggregate to \$400,000, for a two-year term with two (2) one-year renewal options, contingent upon appropriation of funds and City Manager's authorization.

To date, staff has issued task orders to address increasing repair needs in the amount of \$310,784, against the \$400,000 cap for structural bridge engineering consulting services. Staff has identified a need for additional consulting services for the swing bridge at SW 11th Avenue and the SE 7th Street bridge, prior to beginning bridge repairs. However, the current contract cap is inadequate to support the additional necessary consulting services. For such reason, staff is requesting the contract cap to be increased by an additional \$209,759.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$209,759 for proposed cap increase. Funds for the proposed increase are available in the FY 2021 Community Investment Plan, in the account listed below. Future task orders funding is contingent upon the approval and appropriation of the annual budgets.
