TITLE: Resolution Approving a Request for a Special Permit to Extend

Construction Hours for the Broward County Convention Center Subject to the Requirements of Section 17-10 – Construction of Large or Complex Projects (Transportation and Non-Transportation) of the City of Fort

Lauderdale's Code of Ordinances - (Commission District 4)

## Recommendation

Staff recommends the City Commission consider adopting a resolution approving a request for a special permit to extend construction hours for the Broward County Convention Center subject to the requirements of Section 17-10 – Construction of Large and Complex Projects (Transportation and Non-Transportation).

# **Background**

Due to unforeseen circumstances related to weather and the pandemic, which have substantially delayed completion of the Broward County Convention Center ("Convention Center") expansion, Broward County ("County") requested approval of an extension of construction hours. On March 2, 2021, the City Commission approved the described request through Resolution 21-52, permitting Broward County to extend the hours of construction subject to the limitations of the submitted noise management plan as listed below in Table 1.

To address the need for additional time to meet the completion date of the Convention Center the County made a supplemental request to allow for concrete pours that could last up to 72 hours depending on the weather and availability of material. On April 20, 2021, the City Commission approved this modification to the original request through Resolution 21-73.

The County originally indicated the request was for work until October 2021; however, the City Commission limited both requests until June 16, 2021, with the understanding they would consider an extension request, if needed. The County is requesting the extension be granted so that they may complete construction, on or before the time the Fort Lauderdale International Boat Show begins.

The new request is to extend the construction hours per that same restriction as outlined and approved under both Resolutions 21-52 and 21-73 from June 15, 2021 to October 31, 2021. Please see Exhibit 1 for more information.

The County remains committed to addressing complaints as outlined in Noise Management Plan (please see Exhibit 1 pages 6 through 8 for specific information).

To date, the City has not received noise complaints about the construction work on the convention center.

The City Commission may approve proposed request pursuant to Section 17-10 – Construction of Large or Complex Projects (Transportation and Non-Transportation); Exemption for Time to Comply, which states:

The City Commission may authorize additional special permit extensions of time beyond the authority of the City Manager through adoption of a resolution upon a showing of good cause when it is demonstrated the special permit is in the best interests of public health, safety, and convenience. The City Commission may revoke such special permit if it is found that a violation of the special permit has occurred or if it is found that the special permit no longer serves the interest of the public health, safety, and convenience.

### **Resource Impact**
