TITLE: Motion Approving the Purchase and Installation of Sports Lighting via Clay

County Contract – Musco Sports Lighting, LLC - \$4,124,495- (Commission

Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for the purchase and installation of sports lighting from Musco Sports Lighting, LLC in the estimated amount of \$4,124,495 *via* the Clay County Contract 18/19-2.

Background

The athletic field lighting in many of our parks is outdated and inefficient. In many cases, manufacturers are no longer making replacement fixtures, which result in lower lighting levels and dangerous playing conditions. The proposed project will upgrade athletic field lighting at eight different parks to include Bayview, Croissant, Floranada, Florence C. Hardy, Holiday, Mills Pond, Osswald, and Sunset. There will be upgrades made to soccer fields, football fields, baseball fields, softball fields, lacrosse fields, basketball courts, and tennis courts. Upgrading lights to LED will result in a 40% to 60% decrease in electricity usage, increased lighting levels and safety, as well as reduced maintenance costs. These upgrades are included in the Parks Bond program as needed improvements.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may piggyback a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the chief procurement officer determines that it is practicable and advantageous for the city to employ this method of procurement. The chief procurement officer has determined that it would be practicable and advantageous for the city to use this method of procurement for this agreement. The proposed purchase will be made in accordance with Clay County Contract No. 18/19-2 from Musco Sports Lighting, LLC in the amount of \$4,124,495.
