

**AGREEMENT BETWEEN CITY OF FORT LAUDERDALE
AND MUSCO SPORTS LIGHTING, LLC FOR
VARIOUS EQUIPMENT AND AMENITIES FOR PARKS AND PLAYGROUNDS**

THIS AGREEMENT, made and entered into this 23 day of June, 2021, is by and between the City of Fort Lauderdale, a Florida municipality ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and **Musco Sports Lighting, LLC**, an Iowa limited liability company authorized to transact business in Florida ("Contractor"), whose address is **100 1st Avenue West, Oskaloosa, Iowa 52577, Email: musco.contracts@musco.com, Phone: 800-825-6030.**

WHEREAS, the City and the Contractor wish to enter into an agreement for **VARIOUS EQUIPMENT AND AMENITIES FOR PARKS AND PLAYGROUNDS** based on an agreement between the Contractor and **CLAY COUNTY, Florida ("Clay County Contract 18/19-2")**.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants set forth herein and other good and valuable consideration, the City and the Contractor covenant and agree as follows:

1. The Contractor agrees to provide to the City **VARIOUS EQUIPMENT AND AMENITIES FOR PARKS AND PLAYGROUNDS** at the price and terms set forth in the **Contractor's Sports Lighting Bid Sheet for Clay County Contract 18/19-2**.

2. This Agreement shall be coterminous with the **Clay County Contract 18/19-2**, which ends its initial three-year term on **May 27, 2022**, with the option to renew for two additional one-year terms.

3. Except with regard to the proposal solicitation process, the terms "**Clay County, Florida**" as set forth in the **Clay County Contract 18/19-2**, where the context permits, mean the City.

4. Notice to the City shall be as follows:

5. The City's Insurance Requirements and General Terms and Conditions, which are attached hereto, are incorporated herein.

6. The Contractor's **Quote**, dated April 20, 2021, is attached hereto and incorporated herein.

7. In the event of a conflict between or among the contract documents or any ambiguity or missing specifications or instruction, the following priority is established:

- A. First, specific direction from the City's city manager (or designee).
- B. Second, this Agreement for **VARIOUS EQUIPMENT AND AMENITIES FOR PARKS AND PLAYGROUNDS**
- C. Third, the City's General Conditions and Insurance Requirements.
- D. Fourth, the Cooperative **Clay County Contract 18/19-2**.

8. The City may cancel this Contract upon written notice to the Contractor in the event the Contractor fails to perform the services as described in this Contract within 30 days following written notice to the Contractor.

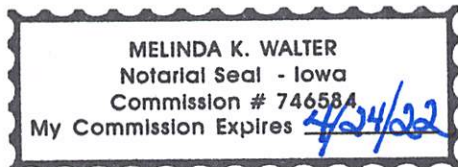
