TITLE: Motion Setting the Public Hearing Dates to Consider the Proposed Fiscal Year 2022 Millage Rate and Budget for the City of Fort Lauderdale and for the Sunrise Key Neighborhood Improvement District - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve Wednesday, September 8, 2021, and Monday, September 13, 2021, as the public hearing dates to consider the proposed Fiscal Year 2022 millage rate and budget for the City of Fort Lauderdale and for the Sunrise Key Neighborhood Improvement District. The public hearings will be held at 5:01P.M. or soon thereafter at City Hall, 100 North Andrews Avenue, Fort Lauderdale, Florida 33301.

Background

Florida Statutes require that a public hearing on the proposed millage rate and tentative budget be held within 80 days but not earlier than 65 days following the certification of the taxable values by the Broward County Property Appraiser (July 1, 2021). Municipal budget public hearings cannot be held on the same days as the Broward County School Board (August 3, 2021, and September 14, 2021) or the Broward County Commission (September 9, 2021, and September 21, 2021).

The City's proposed schedule for the adoption of its millage rate and budget and the Sunrise Key Neighborhood Improvement District's millage rate and budget is presented below:

- August 4 – The proposed millage rate, the rolled-back rate, and the date, time, and place at which a public hearing will be held to consider the proposed millage rate and the tentative budget must be submitted to the Property Appraiser and in the Department of Revenue's eTRIM application (required within 35 days of certification of value).
- September 8 – Public hearing will be held at 5:01 P.M. in the Fort Lauderdale City Commission Chamber to adopt a tentative millage rate and budget by resolution.

- September 10 – City will advertise its intent to adopt a final millage rate and final budget and date of final public hearing (required within 15 days of adoption of the tentative budget). The public hearing to adopt the final millage rate and budget must be held two to five days after the advertisement appears in the newspaper (s. 200.065(2), F.S.).
- September 13 – Public hearing will be held at 5:01 P.M. in Fort Lauderdale City Commission Chamber to adopt final millage rate and final budget by resolution.

Resource Impact
