TITLE:	Public Hearing - Resolution Granting a Waiver of Limitations at 1207 Seminole Drive, for the Installation of One Finger Pier and One Wooden Mooring Pile – (Commission District 1)

Recommendation

Staff recommends the City Commission adopt a Resolution, pursuant to Unified Land Development Regulations (ULDR) 19.3(e), granting a Waiver of Limitations for the installation of one finger pier and one wood mooring pile located at 1207 Seminole Drive.

Background

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Sections 47-19.3 (C) and (D) of the Unified Land Development Regulations (ULDR) for the installation of a 25' long by 5' wide wood finger pier (+/- 125 sq. ft.) extending +/- 28.8', and the installation of one (1) wood 12" mooring pile extending a maximum of +/- 48.8 feet from the property line into Seminole Lake.

The applicant's Summary Description specifies that the proposed finger pier and mooring pile are necessary to safely moor the resident's vessel during high wind events and severe weather, and to accommodate the vessel perpendicularly due to constraints resulting from the vessel side yard setbacks.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended unanimous approval of the application 13 to 0 (see Exhibit 3) at the June 3, 2021 meeting.

Resource Impact

There is a positive fiscal impact in the amount of \$1,500. Revenue related to the application fee is included in the FY2021 Operating Budget in the account listed below.
