

RESOLUTION NO. 21-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE CITY OF FORT LAUDERDALE'S FINAL FY 2021 - FY 2025 COMMUNITY INVESTMENT PLAN FOR THE FISCAL YEARS BEGINNING OCTOBER 1, 2020, AND ENDING SEPTEMBER 30, 2025, AS AMENDED, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #21-0797, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 20-153, adopted on September 14, 2020, the City Commission of the City of Fort Lauderdale, Florida, adopted the City of Fort Lauderdale Final FY 2021 - FY 2025 Community Investment Plan for the Fiscal Years beginning October 1, 2020, and ending September 30, 2025;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City of Fort Lauderdale's Final FY 2021 - FY 2025 Community Investment Plan for the Fiscal Years beginning October 1, 2020, and ending September 30, 2025, as amended, to the extent appropriated for the Fiscal Year beginning October 1, 2020, and ending September 30, 2021, is hereby amended by appropriating funds as set forth in City Commission Agenda Memo #21-0797.

SECTION 2. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution Approving the Consolidated Budget Amendment to Fiscal Year
2021 – Appropriation - **(Commission District 4)**

Recommendation

Staff recommends that the City Commission adopt a resolution amending the Fiscal Year (FY) 2021 Budget, and FY 2021 – FY 2025 Community Investment Plan (CIP).

Background

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff recommends the City Commission amend the FY 2021 – FY 2025 Community Investment Plan, as revised, by approving the following appropriation:

Public Works

A. Appropriation from Fund Balance – General Fund, General Capital Projects Fund – Hector Park and Virginia S. Young Park Restoration Improvements Project - \$750,000

On December 2019, the Rio Vista Community was impacted by the break of the 54-inch sewer transmission force main, which conveys the sewer from the City of Fort Lauderdale and five surrounding municipalities to the George T. Lohmeyer Regional Wastewater Treatment Plant. These sewer breaks affected both Virginia S. Young Park and Hector Park in the Rio Vista neighborhood. Sanitary sewer overflows on the surface and subsequent emergency pipeline infrastructure repair work caused resulting damages to the existing facilities at both parks as well as surrounding roadways and sidewalks, resulting in the closure of the parks and restriction of traffic flows in and out of the neighborhood.

This new project is for the remaining improvements at Hector Park and Virginia S. Young Park. The work will include the installation of approximately 10 feet of concrete curb around the electrical panel, installation of new artificial turf and completion of punch list items for new playground at Virginia S. Young Park. There will also be a restoration of the median east of Hector Park up to 12th Way, swale restoration, installation of new sod along SE 11th Street, restoration of driveways behind new sidewalk along Ponce de Leon Drive; milling and paving of Ponce de Leon Drive, from SE 9th Avenue to 12th Way, and SE 9th Avenue, from Ponce de Leon Drive to 11th Court.

Funding for the Hector Park and Virginia S. Young Park Restoration Improvements Project in the amount of \$750,000, is available in the General Fund balance.

Staff recommends the City Commission amend the FY 2021 – FY 2025 Community Investment Plan in the amount of \$750,000 for the Hector Park and Virginia S. Young Park Restoration Improvements Project. This item is contingent upon approval of CAM 21-0798.
